1. Proclamation Recognizing September 2023 as National Preparedness Month

Commissioner Aldred read the following proclamation:

WHEREAS, National Preparedness Month, occurring each September, is a call for the

nation's citizens to join in preparing their homes, businesses, and communities

for disasters, including natural and man-made hazards; and

Whereas, the Federal Emergency Management Agency (FEMA) announced the 2023 National Preparedness Month theme, "Take Control in 1, 2, 3," which encourages everyone, especially older adults, to become more prepared; and during this time, we recognize the selfless and brave actions of all who help prepare for, protect from, respond to, mitigate during, and recover from disasters; whether they be paid or unpaid, these individuals, agencies, and organizations are performing essential actions in fostering a culture of preparedness and building community resilience; and

WHEREAS, when individuals take responsibility to prepare themselves, their households, and their communities, the rate of survival and the ability to recover is greatly increased; and

WHEREAS, the Boone County Office of Emergency Management partners with federal, state, regional, local, private, and volunteer agencies to raise awareness of local hazards and to educate on how to prepare for them.

THEREFORE, the County Commission of the County of Boone does hereby recognize September 2023 as National Preparedness Month and calls on all citizens of Boone County, Missouri, to prepare for disasters with their households, family, friends, pets, and neighbors by making a preparedness plan, building a kit, staying informed, and being involved in preparedness activities.

Director of Emergency Management Chris Kelley stated their Preparedness Fair is this Thursday, September 14, 2023, at Stephen's Lake Park from 4 p.m. until 8 p.m. Director Kelley stated there will be a band and lots of Emergency Management partners and vendors. Director Kelley stated he will also be naming the awardee of the Tom Hurley Public Safety award. Director Kelley stated he is looking forward to having everyone come out to learn about preparedness.

time Prosecutor, who would work 100% remotely. Prosecutor Johnson stated this grant requires a 25% County match, which comes from the funding of their existing staff.
