7. Commissioner Reports

Commissioner Thompson stated she was excited about the ongoing work of the Policing/ Justice/ Mental Health Steering Committee for the Missouri Association of Counties. Commissioner Thompson stated they now have ten resolutions in final form to present to the Legislative Committee. Commissioner Thompson stated two of the resolutions suggest the Legislature assist with funding for both a Health and Justice Coordinating Counsel and a data sharing platform. Commissioner Thompson stated the resolution also suggests two first-class counties be selected for a pilot program, including a first-class county that has done at least one sequential intercept mapping. Commissioner Thompson stated those resolutions are heading to the Legislative Committee and then the Executive Committee of the Missouri Association of Counties. Commissioner Thompson stated another resolution suggested that, once people are in county jails and are under court order to be transferred to the Department of Mental Health because they have been found incompetent to proceed, the cost of their care between the date of the order and the date on which they are transferred be absorbed by the Department of Mental Health and not by the County. Commissioner Thompson stated, in September, the Missouri Independent reported there were over 300 people in that situation in jails throughout Missouri and the average length of stay for those individuals was eight months, down from eleven months. Commissioner Thompson stated the cost of those individuals waiting for transfer currently remains with the Counties.
