The meeting was called to order at 1:30PM and roll call was taken.

### Sheriff's Office

1. First Reading: 2023 Edward Byrne Memorial Justice Assistance Grant Award Acceptance

Captain Brian Leer stated this is a federal grant award of \$43,810.00 under the Bureau of Justice Assistance FY23 Edward Byrne Memorial Justice Assistance Grant (JAG). Captain Leer stated they have an intergovernmental agreement between the City of Columbia and the County of Boone such that the City of Columbia Police Department will receive 60% of these funds, being \$26,286.00, and the Boone County Sheriff's Office will receive 40% of these funds, being \$17,524.00. Boone County plans to use the funds for the purchase of a K-9 and a ballistic shield. Captain Leer stated, if approved, they are asking the Presiding Commissioner to accept the award on their behalf moving forward.

Commissioner Kendrick stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

### Road & Bridge

### 2. First Reading: Change Order #32 for the Tom Bass Road Remodel Project

Director of Road & Bridge Greg Edington stated change order #32 is a continuation of the original project and is to replace two interior doors. Director Edington stated they had one exterior door left over from the first remodel and they decided to replace an exterior door for the cost of installation and the frame. Director Edington stated the rest of the change order is for miscellaneous electric circuits.

Commissioner Kendrick stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

### 3. First and Second Reading: Consulting Services Agreement: Pat Schreiner

The County Commission authorizes the County Auditor to re-appropriate unspent FY 2023 grant funds which may be carried forward into FY 2024 according to the terms of the grant award upon determination that a remaining balance of the grant award is available for rebudgeting. In addition, the County Commission authorizes the County Auditor to re-appropriate unencumbered FY 2023 appropriations for projects approved in the FY 2023 budget, including Boone County's American Rescue Plan Act (ARPA) funds, which require extension into FY 2024 for completion.

Commissioner Aldred seconded the motion. The motion carried 3 to 0. **Order #574-2023** 

### Resource Management

5. First Reading: Approval of Extension of the Stormwater Security Agreement and Erosion and Sediment Control Letter of Credit for Ravenwood Plat 1.

Stormwater Coordinator Nicki Rinehart stated they need to extend the letter of credit for this 34-lot subdivision in the amount of \$89,451.34, which covers 150% of the erosion and sediment control costs for lots still owned by the developer.

Commissioner Kendrick stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

6. First Reading: Approval of Extension of the Stormwater Security Agreement and Erosion and Sediment Control Letter of Credit for Ravenwood Plat 2.

Stormwater Coordinator Nicki Rinehart stated they need to extend this letter of credit in the amount of \$72,586.41 for the 18-lot subdivision which covers 150% of the erosion and sediment control costs for plat 2.

7. First Reading: Approval of Stormwater Security Agreement and Erosion and Sediment Control Performance Bond for Atterberry Auctions

This Contract is for the Family Access Center of Excellence (FACE) of Boone County. FACE consists of two program branches: Community-Based Services and School-Based Services. This program helps Boone County families with a child between the ages of 0-19 to improve access to high quality mental health care.

Invoices will be paid from Department 2162 -CSF Program Funding, Account 71106 Contracted Services. \$13,500,000.00 is budgeted for 2024.
