The meeting was called to order at 9:30AM and roll call was taken.

County Clerk

1. First and Second Reading: 2024 Boone Hospital Board of Trustees Election

Commissioner Kendrick stated there were two open positions for the Boone Hospital Board of Trustees, and two individuals filed to run. Commissioner Kendrick stated both Gary Thompson and Judith Starr have been members of the non-elected community board and Judith recently became a member of the elected trustees when a vacancy came open and the Commission had the opportunity to fill that. Commissioner Kendrick stated these are both unopposed seats that would typically appear on the April ballot, but since they are both unopposed, they will be put into place without going on the ballot.

Commissioner Aldred moved now on this day, the County Commission of the County of Boone does hereby accept the attached certification by the Boone County Clerk regarding the election of Hospital Trustees of Boone County. Pursuant to the provisions of 115.124.1 RSMo., no election shall be held for such office and the candidates, Gary Thompson, and Judith Starr, shall assume the duties of their office at the same time and in the same manner as if they had been elected at the April 2, 2024, election. It is further ordered that the Boone County Commissioners are hereby authorized to sign the Commission Order for Gary Thompson for a five-year term and Judith Starr for a four-year unexpired term to serve as a Hospital Trustee of Boone County.

2. First and Second Reading: 2024 Centralia Special Road District Election

It is further ordered that the Boone County Commissioners are hereby authorized to sign the Commission Order for Gary Moore to serve as Commissioner of Centralia Special Road District for a three-year term.
