The meeting was called to order at 1:30PM and roll call was taken.

#### **Boone County Sewer District**

1. First and Second Reading: Resolution with the Missouri Department of Natural Resources

Boone County Regional Sewer District General Manager Tom Ratermann said the purpose of this project is to connect the Phenora North lagoon by gravity sewer to Boone County Regional Sewer District wastewater collection and treatment system and completely remove the Phenora North lagoon. Mr. Ratermann stated the wastewater from Phenora North lagoon will be treated at the Sewer District's Rocky Fork wastewater treatment plant. Mr. Ratermann stated this project is in the Neighborhood Improvement District in Boone County, and NIDs are financed by general obligation bonds, which are retired through a special assessment. Mr. Ratermann

stated the property owners in the NID paid a special assessment in the same manner as a real estate tax. Mr. Ratermann stated Phenora North is a multi-family development that will be serving about 40 units and four different property owners.

Commissioner Thompson moved now on this day, the County Commission of the County of Boone does hereby approve the Resolution authorizing the applications for loans/grants for the Phenora North Sanitary Sewer Neighborhood Improvement District.

## Health Department

## 2. First Reading: City of Columbia Public Health Services Cooperative Agreement

Assistant Director of Boone County Public Health and Human Services Rebecca Roesslet stated the County Contract allows for 33% of the public health costs to be charged to the County. Ms. Roesslet stated the total cost for the upcoming year is a reduction from the prior year of close to \$101,000.00. Ms. Roesslet stated this is due to an adjustment that was made with the billing. Ms. Roesslet stated previously the County had paid 33 1/3% and at the end of the year it was changed to 33%.

Commissioner Kendrick stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

# 3. First Reading: City of Columbia Animal Control Services Cooperative Agreement

Assistant Director of Boone County Public Health and Human Services Rebecca Roesslet stated they provide animal control services around the County. Ms. Roesslet stated this year reflects an increase of \$17,000.00 due to the "comp and class" study performed on all city job classifications, as well as the purchasing of body cameras and an increase to the Humane Society.

Commissioner Kendrick stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

Director of Purchasing Melinda Bobbitt read the following memo:

Boone County Legal Department requested Purchasing route for Commission approval the attached Agreement C000708 - Consultant Services for Boone County Sheriff's Office Regional Training Facility with Peckham & Wright Architects, Inc., d/b/a PW Architects, Inc. of Columbia, Missouri.

Boone County, Missouri received ARPA Grant Funding from the federal government and the County Commission engaged in an RFP process to determine ARPA funding awards.

This ARPA award is for County Contract #C000724 - Boone County Nature School. The ARPA funds will be used for the Boone County Nature School for the construction of a \$6+ million educational center that provides placed-based educational opportunities for students in all six Boone County school districts (Centralia, Columbia, Hallsville, Harrisburg, Southern Boone, and Sturgeon). The ARPA Award will assist in the construction of the educational center which

will provide differentiated instruction and help to address the impacts of lost learning that occurred as a result of the pandemic.

Contract Award is for a not-to-exceed amount of \$200,000.00, and will be paid from Department 2983 - American Rescue Plan Act, Account 82400 - Other Contracts.

Commissioner Thompson moved now on this day, the County Commission of the County of Boone does hereby approve an ARPA Funding Subrecipient Agreement with Columbia Public School District for Boone County Nature School for \$200,000.00.
