Sheriff's Department

1. First Reading: School Resource Officer Agreement with Sturgeon R-V Schools

Captain Brian Leer stated this agreement is for a partnership that has been in place for a long time. Captain Leer stated the Boone County Sheriff's Office continues to serve both Sturgeon and Harrisburg with School Resource Officers, and they have a long-standing commitment to developing trust and relationships among law enforcement, staff and students. Captain Leer stated this program pays dividends that are unseen, and this agreement is for the 2024-2025 school year. If approved, it will stay in place until the end of the school year. Captain Leer stated the Sheriff's Office will supply a deputy to be assigned to the school district during school hours, and in return, the school district agrees to pay 25% of what a Deputy costs the Office, which is \$20,159.89.

Commissioner Kendrick stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available commission meeting with appropriate order for approval.
