The meeting was called to order at 9:30AM and roll call was taken.

#### **Boone County Sheriff's Office**

1. First Reading: Moniteau County Sheriff's Office K-9 Basic Training Agreement Captain Brian Leer stated this agreement is for a new K-9 and their trainer. Commissioner Kendrick stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

## 2. First Reading: Cooper County K-9 Maintenance Training Agreement

Captain Brian Leer stated this is a one-year training agreement, and can be renewed for two additional one-year terms if approved. Captain Leer stated if approved, the Boone County Sheriff's Department will continue to train Cooper County's K-9 and handler.

## 3. First Reading: Budget Amendment - Department 1253 - Cyber Crime 24/25

Captain Brian Leer stated they applied and were granted money from the State Cyber Crime grant and now need to budget the 2024 portion. Captain Leer stated they are asking to move \$194,623.00 into the appropriate funds to pay the salary and benefits for the investigators in the Cyber Crimes unit to purchase the software they want to purchase. Captain Leer stated the 2025 portion is already budgeted in the 2025 request.

Commissioner Kendrick stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

## 4. Second Reading: School Resource Officer Agreement with Sturgeon R-V Schools – First Read 10.22.24

# 6. First Reading: Budget Revision - Department 2161 - Cover Programs for Child Advocacy

Director of Community Services, Joanne Nelson, read the following memo: The Community Services Department requests approval for the 2024 Contingency Fund contract with Missouri Network Against Child Abuse. The contract was submitted by Missouri Network Against Child Abuse as a Contingency Fund request to the Boone County Children's Services Fund. The contract will pay to assist in covering the costs associated with the establishment of a Child Advocacy Center in Boone County.

The contract will begin upon approval by the Boone County Commission, and extend until December 31, 2025, or upon completion of the establishment of the Child Advocacy Center of Boone County. The reimbursement is provided to Missouri Network Against Child Abuse who is subcontracting the work to Partner for Better. A total of \$33,000.00 will be provided through department number 2161 and account number 71106. The current fund balance is \$415,108.24.

Commissioner Kendrick stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

# 7. First Reading: Budget Revision - Department 2131 - Cover Meeting Space & Catering Cost

Director of Community Services, Joanne Nelson, stated these funds are being taken from Cradle to Career Alliance, which had given them \$100,000.00 to work on Upward Mobility projects. Director Nelson stated this year they decided to hold a poverty simulation, and they needed to pay for the meeting space and catering.

Commissioner Kendrick stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

8. First and Second Reading: Request to Hire Above FHR for Position 433, Deputy Court Marshal

# 10. First and Second Reading: Job Classification Committee Recommendations for Fourth Quarter 2024 Requests

Director of Human Resources Angela Wehmeyer read the following memo:

The Job Classification Committee met in person on Wednesday, October 16, Friday, October 18, and Monday, October 21 to review and discuss requests for new job classifications and pay range adjustments from the following departments for the current 2024 budget year:

1. 13<sup>th</sup> Judicial Circuit Court-Juvenile Justice Center

The Committee discussed requests from the 13<sup>th</sup> Judicial Circuit Court to create two new classifications due to the receipt of grant funding from the Office of Juvenile Justice and Delinquency Prevention through the Building Local Continuums of Care to Support Youth Success grant effective October 1, 2024, through March 31, 2026.

The Job Classification Committee makes the following recommendations for two new position classifications to be implemented in the 2024 budget year:

- Create a new classification for a Court Grant Funded Temp on a range 25. The pay rate for the position shall be set at \$22.00 per hour for the duration of the grant period.
- Create a new classification for a Court Grant Funded Temp II at on a range 35. The pay rate for the position shall be set at \$30.00 per hour for the duration of the grant period.

Both positions will be budgeted for 40 hours per week through March 31, 2026, and be eligible for all applicable county benefits.

2. Boone County Joint Communications

The Committee discussed requests from the Director of Joint Communications to reclassify an existing Training/Quality Assurance Coordinator to a Training/Quality Assurance Manager due to the expansion and development of the Boone County Joint Communications Emergency Telecommunicator training program.

The Job Classification Committee makes the following recommendation to be implemented in the 2024 budget year:

• Reclassify Position 793, Training/QA Coordinator (Non-Exempt, Class Code 409200, Range 35) to a new classification of Training/QA Manager, FLSA Exempt, on a Range 49.

Commissioner Aldred moved now on this day, the County Commission of the County of Boone does hereby approve the recommendations from the Job Classification Committee for requests for Budget Year 2024 contained within the attached "Recommendations from the Job Classification Committee for the Fourth Quarter of Budget Year 2024" memo, dated October 23, 2024.

Commissioner Thompson seconded the motion. The motion carried 3 to 0. **Order #512-2024** 

11. First and Second Reading: Request to Convert Position 771, Cartographer from a Part-Time, Non-Benefited Position to a Full-Time, Benefited Position

Director of Human Resources Angela Wehmeyer stated this position in the Assessor's Office has been vacant all year, and the Assessor has asked that the position be changed from part-time to full-time.

Commissioner Thompson moved now on this day, the County Commission of the County of Boone, does hereby authorize the request to convert position 771, Cartographer (class code 109600, Range 35), from one part-time, non-benefitted position to one full-time, benefited position to be budgeted at 2,080 hours per year.

## 12. First Reading: Budget Amendment - Department 1195 - Increase Budget Insurance Activity

Director of Human Resources Angela Wehmeyer stated this Budget Amendment is for \$44,200.00 due to loss activity, which caused us to exceed the budget in the general fund account.
