#### 4. First and Second Reading: Set Aside of Salary Plan Maximum for FY2025

Director of Human Resources Angela Wehmeyer stated she is requesting to set aside the salary plan maximum for the 2025 budget year. Director Wehmeyer stated this has been done before

since they have been working on the salary plan. Director Wehmeyer stated normally, when employees hit the salary plan maximum, they aren't eligible for merit and then the merit isn't calculated based on that position. Director Wehmeyer stated lifting the cap will allow those employees to receive increases, and will allow the auditor to calculate merit based on those positions.

Commissioner Thompson moved now on this day, the County Commission of the County of Boone does hereby set aside the Annual Salary Maximum set out in the Salary Plan adopted in Commission Order 563-2022 for the FY2025 budget year.

5. First and Second Reading: Job Classification Committee Recommendations for Budget Year 2025 Requests

Director of Human Resources Angela Wehmeyer read the following memo:

The Job Classification Committee met in person on October 16, October 18, and October 21, to review and discuss requests for new job classifications and pay range adjustments from the following departments for the current 2024 budget year:

1. 13<sup>th</sup> Judicial Circuit Court-Juvenile Justice Center

The Committee discussed requests from the 13<sup>th</sup> Judicial Circuit Court to create two new classifications, due to the receipt of grant funding from the Office of Juvenile Justice and Delinquency Prevention, through the Building Local Continuums of Care to Support Youth Success grant effective October 1, 2024, through March 31, 2026.

The Job Classification Committee makes the following recommendations for two new position classifications to be implemented in the 2024 budget year:

- Create a new classification for a Court Grant Funded Temp on a range 25. The pay rate for the position shall be set at \$22.00 per hour for the duration of the grant period.
- Create a new classification for a Court Grant Funded Temp II at on a range 35. The pay rate for the position shall be set at \$30.00 per hour for the duration of the grant period.

Both positions will be budgeted for 40 hours per week through March 31, 2026, and be eligible for all applicable county benefits.

2. Boone County Joint Communications

The Committee discussed requests from the Director of Joint Communications to reclassify an existing Training/Quality Assurance Coordinator to a Training/Quality Assurance Manager due to the expansion and development of the Boone County Joint Communications Emergency Telecommunicator training program.

The Job Classification Committee makes the following recommendation to be implemented in the 2024 budget year:

 Reclassify Position 793, Training/QA Coordinator (Non-Exempt, Class Code 409200, Range 35) to a new classification of Training/QA Manager, FLSA Exempt, on a Range 49.

Commissioner Thompson moved now on this day, the County Commission of the County of Boone does hereby approve the recommendations from the Job Classification Committee for requests for Budget Year 2025 contained within the attached "Recommendations from the Job Classification Committee for Budget Year 2025" memo dated November 5, 2024.

Rollingwood Blvd., Columbia, MO 65202. The previous Commission Order accepting the Irrevocable Letter of Credit is 575-2023.

The purpose of this memo is to request the acceptance of the Stormwater Security Agreement and Erosion and Sediment control Irrevocable Letter of Credit for Concorde South Plat 1-B, Lot 1-A.

The Irrevocable Letter of Credit was issued by Mid America Bank in the amount of \$51,300.00. Said Irrevocable Letter of Credit was issued on behalf of Concorde Plaza, LLC for construction of a 23,100 square foot commercial building, associated parking, infrastructure, and stormwater improvements located at Concorde South, Plat 1-B, Lot 1-A, E. Meyer Industrial Blvd., Columbia, MO 65201.

8. First Reading: Award of Amendment #1 to Contract C000377 from cooperative contract NCPA-01-97, Synnex Advanced Technology Solutions Aggregator - GETAC In-Car Video Recording and Body Camera System Products, Services and Support Maintenance for the Boone County Sheriff's Office

Senior Buyer Liz Palazzolo read the following memo:

Amendment #1 to contract C000377 awarded from cooperative contract NCPA-01-97, as cited above, for the Boone County Sheriff is being amended to add two renewal options. This is consistent with the original terms of contract that allow maintenance agreements established under the original term to extend a total of five years to complete the maintenance coverage quoted. At the time the contract was first awarded, this detail was overlooked. At the time the original GETAC in-car and body camera systems were purchased, the original quote to the Boone County Sheriff's Office includes acquisition and 5-year maintenance coverage. Amendment #1 corrects the contract term to include all 5 years for on-going maintenance on the GETAC equipment.

The contract with Upstate Wholesale Computers, d/b/a Brite Computers of Victor, New York, was originally awarded May 12, 2020 via Commission Order 215-2020.

The Sheriff's Office will make maintenance payments for its GETAC equipment using this contract as amended. Payment will reference these codes:

- 1251 General Fund Sheriff Operations/70100 Software Subscriptions: \$54,040.32
- 1255 General Fund Detention Operations/70100 Software Subscriptions: \$3,377.52.

This amendment adds the federal clauses required for federal grant money utilized by Boone County for grant-funded projects.

This is a Term and Supply contract.

Senior Buyer Liz Palazzolo read the following memo:

Amendment #1 to contract C000688 awarded from RFB 32-29SEP23, the Boone County Qualified Vendors List (QVL) for Small Interior and Exterior Construction Projects to Professional Contractors & Engineers (PCE) awards the Judges Office Renovation project. Contract C000688 is one of six contracts awarded as Countywide Term and Supply contracts. The Judges' Chambers Renovation at the Boone County Courthouse is overseen by the Boone County Facilities Management Department. Plans were prepared by PW Architects. PCE will perform the actual renovation work.

Pursuant to the terms of the QVL, the two contractors (Xperience and PCE) who identified that they were able to do construction and plumbing work were contacted for a quote. Professional Contractors & Engineers (PCE) of Columbia, Missouri provided an acceptable quote to perform the small interior construction project, for a total not-to-exceed price of \$86,630.00.

Contract C000688 with PCE was originally awarded November 02, 2023 by Purchasing Director Melinda Bobbitt.

A budget amendment was approved for this project October 22, 2024 by Commission Order 505-2024. Payment for project will reference these codes:

• 6200 – Capital Repair & Replacement - General/60110 -Major Building Repairs/Replacement: \$86,630.00

14. Second Reading: Nuisance Abatement: Parcel #12-204-10-08-017.00 01 - First Read 10.31.24

Commissioner Thompson moved now on this 7th day of November 2024, the County Commission of Boone County, Missouri met in regular session and entered the following findings of fact, conclusions of law and order for abatement of nuisance:

#### Findings of Fact and Conclusions of Law

The County Commission finds as fact and concludes as a matter of law the following:

- 1. The Boone County Code of Health Regulations (the "Code") are officially noticed and are made a part of the record in this proceeding.
- 2. The City of Columbia/Boone County Health Department administrative record is made a part of the record in this proceeding and incorporated herein by reference. In addition, any live testimony of the official(s) of the department and other interested persons are made a part of the record in this proceeding.

- 3. A public nuisance exists described as follows: trash, rubbish, junk, and tall grass/weeds
- 4. The location of the public nuisance is as follows 7800 Sharidan Blvd, a/k/a parcel# 1220410080170001, Willow Way Valley Lot 17, Section 10, Township 49, Range 12 as shown by deed book 4412 page 0108, Boone County
- 5. The specific violation of the Code is: junk, trash and rubbish and grass/weeds in excess of 12" on premises in violation of section 6.3 and 6.5 of the Code.
- 6. The Health Director's designated Health Official made the above determination of the existence of the public nuisance at the above location. Notice of that determination and the requirement for abatement was given in accordance with section 6.10.1 of the Code on the 14 day of November 2023 and 13 June 2024, to the property owner.
- 7. The above-described public nuisance was not abated. As required by section 6.10.2 of the Code, the property owner was given notice of the hearing conducted this date before the Boone County Commission for an order to abate the above nuisance at government expense with the cost and expense thereof to be charged against the above-described property as a special tax bill and added to the real estate taxes for said property for the current year.
- 8. No credible evidence has been presented at the hearing to demonstrate that no public nuisance exists or that abatement has been performed or is unnecessary; accordingly, in accordance with section 6.10.2 of the Code and section 67.402, RSMo, the County Commission finds and determines from the credible evidence presented that a public nuisance exists at the above location which requires abatement and that the parties responsible for abating such nuisance have failed to do so as required by the Health Director or Official's original order referred to above.

# Order For Abatement Chargeable As a Special Assessment To The Property

Based upon the foregoing, the County Commission hereby orders abatement of the above-described public nuisance at public expense and the Health Director is hereby authorized and directed to carry out this order.

It is further ordered and directed that the Health Director submit a bill for the cost and expense of abatement to the County Clerk for attachment to this order and that the County Clerk submit a certified copy of this order and such bill to the County Collector for inclusion as a special assessment on the real property tax bill for the current year in accordance with section 67.402, RSMo.

Whereas, Boone County encourages all residents, businesses, and organizations to recognize Operation Green Light for Veterans and shine a green light to let veterans know they are seen, appreciated, and supported.

Therefore, with designation as a Green Light for Veterans County, the Boone County Commission does hereby honor the service and sacrifice of our men and women in uniform transitioning from Active Service and encourages its citizens in patriotic tradition to recognize the importance of honoring all those who made immeasurable sacrifices to preserve freedom by displaying a green light in a window of their place of business or residence.
