The meeting was called to order at 1:30PM and roll call was taken.

Auditor

1. Second Reading: Approval of FY2025 Budget - First Read 11.14.2024

Boone County Auditor Kyle Rieman stated this budget was mainly focused on public safety. Auditor Rieman stated they have many projects, like the Law Enforcement Training Center and expanding infrastructure. Auditor Rieman stated other big capital projects are the Rural Gravel Stablization initiative, the Bonne Femme Church Road project, and the Richland Road project.

Commissioner Aldred moved now on this day, the County Commission of Boone County does hereby approve and adopt the Boone County Operating Budget for fiscal year 2025. The adopted operating budget shall consist of all appropriations included in the Proposed Budget submitted to the County Commission by the County Auditor, subject to the adjustments shown in the attached schedule of Commission Directed Changes to the fiscal year 2025 Proposed Budget. Final wage and benefit appropriations for each office and department have been calculated using actual salaries in effect as of December 11, 2024, incorporating all approved range re-classifications having an effective date of January 1, 2025.

Total appropriations are set forth by line item and are summarized as follows:

- 1) by category of expenditure (i.e., class 1, class 2, etc. up to and including class 9.).
- 2) by office, department or spending agency; and,
- 3) by fund.

Spending may not exceed appropriations at the class level for a given office, department, or spending agency without approval pursuant to the County's Budget Adjustment Policy. Total appropriations for each fund are set forth in the individual Fund Statements and are published in the County's FY 2025 Budget. The Proposed Budget submitted by the County Auditor, which is hereby incorporated into this appropriation order by reference, contains detailed documentation and descriptions for each line-item account within each category of expenditure. Appropriations shall be expended only for the purposes that are within the intent of the category in which they are included.

The County Commission approves all employee positions included in the Proposed Budget, adjusted for Commission-directed changes noted in the attached schedule, together with the specified budgeted hours, range, and benefit status for each position. Certain positions may be subject to additional Commission Order approval, per County Policy, before those positions can be advertised or filled.

The County Commission approves appropriations for the specific fixed assets identified in the various fixed asset appropriation accounts and authorizes procurement of the same in accordance with the County's Purchasing Policy adopted by the County Commission. The County Commission tentatively fixes the property tax rates necessary to finance the budget which are shown in the attached Draft Revenue Commission Order.

The County Commission authorizes the County Auditor to re-appropriate unspent FY 2024 grant funds which may be carried forward into FY 2025 according to the terms of the grant award upon determination that a remaining balance of the grant award is available for rebudgeting. In addition, the County Commission authorizes the County Auditor to re-appropriate unencumbered FY 2024 appropriations for projects approved in the FY 2024 budget, including Boone County's American Rescue Plan.

Commissioner Thompson seconded the motion. The motion carried 3 to 0. **Order** #613-2024

Boone County Sheriff's Office

2. First Reading: Budget Amendment - Department 2550 - Cover Class 7

Captain Brian Leer stated this request is to move funds from the cash balance for outsource services within the Sheriff's revolving fund. Captain Leer stated this would cover the conceal and carry weapon permit finger printing fees that are anticipated for the remainder of the year. Captain Leer stated the Missouri Highway Patrol bills the Sheriff's Office for those fees and that's what this \$1,100.00 will cover.

Commissioner Kendrick stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

3. Second Reading: Audrain County Sheriff's Department K-9 Maintenance Training Agreement – First Read 12.17.24

Commissioner Thompson moved now on this day, the County Commission of the County of Boone does hereby approve the attached K-9 Maintenance Training Agreement between Boone County and Audrain County.

The terms of the Agreement are set out in the attached and the Presiding Commissioner is authorized to sign said Agreement.

4. Second Reading: Request by CKL Property Management, LLC to rezone from General Commercial (C-G) and Planned General Commercial (C-GP) to Planned Industrial (M-LP) and to approve a review plan on 4.1 acres located at 7400 E I-70 Drive SE, Columbia – First Read 12.10.24

Commissioner Kendrick stated conditions two and three were struck and now conditions two, three and four are new, and the new conditions being considered for potential approval of this redevelopment would be a second condition which reads, "The property owner shall comply

with all requirements of the Boone County Fire Protection District and provide access, at reasonable times, to Fire District staff for periodic inspections", which is to satisfy the fire marshals' requirements for fire code safety.

Commissioner Thompson stated this gives the applicant broad enough ability to comply with the requirements of the fire marshal, who has indicated his willingness to accept fire walls instead of a sprinkler system, because the fire flow in that area is insufficient to handle it as a wet suppression system. Commissioner Thompson stated this will give the fire marshal the ability to ensure the other points of agreement, including the parking vehicles in the building, what is stored in the building and those types of things.

Commissioner Aldred moved now on this day, the County Commission of the County of Boone, does hereby approve a request by CKL Property Management, LLC to rezone from General Commercial (C-G) and Planned General Commercial (C-GP) to Planned Industrial (M-LP).

Now on this day, the County Commission of the County of Boone, does hereby approve a request by CKL Property Management, LLC to approve a review plan for 7400 East I-70 Southeast on 4.1 acres, located at 7400 E I-70 Drive SE, Columbia, subject to the following conditions:

- 1. All agreements and documentation related to the provision of sewer service be completed to the satisfaction of the BCRSD and the Director of Resource Management prior to submission of the Final Development Plan.
- 2. The property owner shall comply with all requirements of the Boone County Fire Protection District and provide access, at reasonable times, to Fire District staff for periodic inspections.
- 3. The access to Sunny Vale Drive shall be gated and locked at all times except to allow access for emergency services and to allow semi-trucks, making deliveries to the site, to orient to the loading dock.
- 4. When the west driveway access is closed by the Missouri Department of Transportation, the access to Sunny Vale Drive will also be closed until improvements to Sunny Vale Drive are completed to the satisfaction of the Director of Resource Management.
- 5. Submit a detailed Landscaping Plan that includes species, size, and provisions to replace dead vegetation for the proposed screening along the 6-foot security fence along I-70 Drive SE that is acceptable to the Director of Resource Management prior to submission of the Final Plan.
- 6. The Stormwater controls for the site are required to be installed and completed in compliance with the plans previously approved for the site and must be implemented to the satisfaction of the Director of Resource Management.
