### **Emergency Management**

# 1. First Reading: Boone County LEPC/OEM Service Level Agreement

Director of Emergency Management Chris Kelley stated, on January 29, 2025, a board meeting of all the voting members of the Local Emergency Planning Committee (LEPC) approved this new Service Level Agreement. Director Kelley stated there were discrepancies between the existing bylaws and the current needs. Director Kelley stated the Service Level Agreement now addresses sunshine law requests about LEPC data or information.

## 15. Commissioner Reports

Commissioner Thompson stated she went to Jefferson City yesterday morning for a House hearing on mental health issues. The hearing primarily focused on the DOJ report calling to task public administrators and DMH for violating the ADA across the state by placing clients in settings that do not meet the Olmstead requirements. Commissioner Thompson stated we are fortunate that our new Representative Gregg Bush is part of that committee, and she hopes his expertise in the medical world will help them come up with solutions.

Commissioner Kendrick stated, at approximately 6 p.m. last night, Boone County Joint Communications began getting 911 calls for Boone County that were being automatically rerouted to Jefferson City Police Department as part of the rollover, which began a quick fact-finding mission of discovering Bright Speed had a fiber line cut near Jefferson City. Commissioner Kendrick stated this fiber line cut impacted multiple 911 centers. Alerts were sent out encouraging people in Boone County to call 311 in case of emergency. However, if they still called 911, those calls would continue to be routed to Jefferson City, where there were two dispatchers to handle those calls and dispatch them. Commissioner Kendrick stated the fiber line has now been repaired and calls have resumed regular routing to Boone County Joint Communications.
