Purchasing requests approval of contract Sole Source# 173-123123 SS for the purchase of a Chloride Study Related to the Macroinvertebrate Data Mining Study of Hinkson Creek from Geosyntec Consultants, Inc. of Jefferson City, Missouri. The Purchasing Department also requests approval of Contract C000683 that is being established from the Sole Source. The contract is being established on behalf of the Boone County Resource Management Department. The Chloride Study relates to the initial Macroinvertebrate Data Mining Study of Hinkson Creek performed by Geosyntec Consultants, Inc. under contract 20-07NOV 19. The County requested competitive proposals from various vendors through a Request for a Statement of Qualifications posted as 20-07NOVI 9. Geosyntec Consultants, Inc. was the only respondent,

and a contract was awarded to the vendor for the original Macroinvertebrate Data Mining Study of Hinkson Creek. During that study, Geosyntec noticed a correlation between chloride concentrations and macroinvertebrate health. This new study builds on the previous work. The single feasible source has been advertised in both the Missourian and the Columbia Tribune. No other vendors have come forth to indicate that they are able to provide it. The contract period will run for a three-year period starting October 26, 2023, through October 25, 2026.

Payments under the contract will reference the following department and object codes: • 1725 - General Fund Resource Management Storm water Planning/71100 - Outsourced Services: \$124,500.00.

Pursuant to RSMo §140.230 the Commission is authorized to approve claims for any tax sale surplus being held by the County Treasurer associated with the County Collector's annual tax sale as part of a redemption or to claimants after the expiration of the applicable redemption period. In this instance, the Collector's Deed was issued on 9/11/2024 (recorded at Book 5911, Page 180 Boone County records) which ended the defeasible right to redeem under RSMo §140.340 and began the 90-day claims period contemplated in RSMo §140.230.2. No claims have been received. The owner of record at the time of the sale has applied for the surplus. The documentation which supports this claim is made a part of this record. The application of the Claimant to the County Treasurer for the surplus funds is timely.

The County Treasurer, based upon the documents presented to her office and made a part of this record, is satisfied Byron Hickam is entitled as the owner of record at the time of the sale to the total surplus of \$9,777.92.

NOW, THEREFORE, upon the recommendation of the County Treasurer and the evidence made a part of this record, the County Commission hereby approves the application for surplus from the owner of record and directs the payment \$9,777.92 per the surplus application to Byron Hickam, c/o Adam Dowling, Attorney at Law, 1000 West Nifong Blvd., Bldg 7, Ste. 201, Columbia, Missouri 65203.

17. Commissioner Reports

Commissioner Thompson stated her brother is a 1976 graduate of the United States Military Academy at West Point, served 30 years in the United States Army, with much of that time spent at Ft. Sam Houston, and on the front line in Desert Storm. Commissioner Thompson stated she would like to read a letter that her brother wrote to be published in the San Antonio newspaper.

To the editor: As the former Director of the University of Texas Health Science Center, San Antonio's National Cancer Institute, I was stunned by the White House's plan to reduce the indirect cost rate for Federal Grants to 15%. I am most familiar with grants from the National Institutes of Health, NIH, and specifically the National Cancer Institute. These grants have enabled me and my colleagues to make discoveries in the prevention, detection and treatment of cancer and have saved lives around the world. Many of our discoveries were only possible through clinical trials often involving hundreds or thousands of participants. One of my greatest joys has been to visit with a patient and their spouse and make a treatment recommendation based on the study we conducted and to inform them that the specific treatment will significantly reduce their risk of dying of cancer. Indirect funds are dollars provided to research institutions used to pay for costs that can not be directly linked with a research project. Indirect cost rates are based on long-established factors and vary from institution to institution and are periodically updated. These are related to the institutions costs to providing buildings, maintenance, staff, equipment and other costs required to conduct research. Specifically in the case of cancer clinical trials, they help cover the cost of research staff who help educate patients

about new cancer treatments that are often only available through a clinical trial. Tracking patients progress, collecting and analyzing data as well as the cost of the building where the study is conducted. Often, even with indirect costs, clinical trials are a money losing proposition for the institution but are essential to discover new cancer cures. Many clinical trials that I have led, which have fundamentally changed cancer treatment, could not have been completed without indirect funds. We now face a proposed across the board reduction in the indirect funds rate for all institutions down from the current level to 15%. At my former institution, the UT Health Science Center, the indirect rate is about 50%. While some grants have much lower indirect rates, with the published University of Texas San Antonio Health Sciences Center NIH funding level, in 2023 of \$131.5 million dollars a drop from 50% to 15% would be a \$46 million dollar reduction in NIH funds alone. There are many other sources of federal funding including the National Science Foundation Department of Defense, etc so the total amount could be much more. It is estimated that the total reduction for US Research Institutions will be \$9 billion dollars. The impact of this change will be catastrophic for most research institutions, many of which are located in San Antonio. Options for cancer center directors and university presidents around the United States would be 1. To take funds from other education or community services activities; 2. Shutter research programs; 3. Limit the number of grants that can be submitted; 4. Discontinue plans for promising new programs and/or 5. End construction of new scientific facilities. This process is being repeated around the United States in hundreds of premier research institutions. The results will be the greatest reduction in scientific and medical progress seen in our nation's history. The opportunity and need for scientific progress has never been greater and the United States has been at the forefront of scientific advances for the last century. Our patients with cancer, Alzheimer's, heart disease, diabetes and other diseases demand that we continue our work to eliminate suffering and death from these diseases.

Commissioner Thompson stated the front page of The Missourian today echoed what her brother wrote. Commissioner Thompson stated this is catastrophic in terms of treatment of individuals with cancer and other diseases, and it is catastrophic for the general health and welfare of our county, our state, and our nation. Commissioner Thompson stated she does not know how we will survive this, on many levels.

Commissioner Kendrick stated the University of Missouri has made significant financial investments, capital investments, doubling down on medical research, including the Roy Blunt Institute. Commissioner Kendrick stated part of the reason why it is named after him is his assistance in landing not just federal earmarks for the construction but for the NIH support as well. Commissioner Kendrick stated this will be felt locally and globally.
