2. First Reading: MoDOT Soft Match Credit exchange request between Boone County and Osage County

Chief Engineer Jeff McCann requested approval to exchange \$200,000 of Boone County's soft match credit with MoDOT for \$130,000 from Osage County. Chief Engineer McCann stated

that equates to \$0.65 per \$1 exchange. The benefit of exchanging the soft match credit for the cash is that Boone County will be able to use that cash on not only federally-funded projects, but on County-funded projects as well.

Commissioner Kendrick stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

4. First Reading: Acknowledging receipt of MoDOT road construction plans for a roundabout at Hanover Blvd and State Route PP

Counselor Dykhouse stated the plans that have been filed with Clerk Lennon's office, and will ultimately be acknowledged by the County Commission, have to do with a roundabout project at the intersection of Hanover Blvd and State Route PP, also known as Clark Lane.
