The plans and specifications for the Hartsburg Hills Road Neighborhood Section 1. Improvement District Project, Project Number 9667, providing for an estimate cost of \$72,284.00 will be assessed against property benefited by the improvements, are hereby determined to be final and complete and the improvements described therein are ordered to be made.

Section 2. The County of Boone expects to make expenditures on and after the date of passage of this Order in connection with the Project, and the County of Boone intends to reimburse itself for such expenditures with the proceeds of notes or bonds of the County of Boone. The maximum principal amount of notes or bonds expected to be issued for the Project is \$90,355.00.

The County of Boone hereby authorizes the Treasurer to issue temporary Section 3. notes pursuant to the Act to finance the costs of the Project until the Project is completed and final costs are determined for the purpose of making assessments against the owners of property within the district.
