SUBJECT: Position 185, Corrections Officer (Roger L. Loughridge)

The above employee was called to National Guard active duty on November 28, 2001 for a period of time not to exceed 365 days.

We need to replace this officer on temporary basis until Mr. Loughridge returns from military leave. I would like to hire a corrections officer on a temporary basis until Mr. Loughridge is able to return to his job with Boone County.

I want to be able to offer benefits to the temporary employee since this period of time that may last until the end of November 2002. This would result in paying double employee benefits for the period of time that this employee works.

- (a) THIS IS NOT A PERMANENT CHANGE OF STATION (PCS). NORMAL PCS ENTITLEMENTS AND ALLOWANCES AND RELOCATION OF FAMILY MEMBERS ARE NOT AUTHORIZED. FAMILY MEMBERS ARE NOT AUTHORIZED TO ACCOMPANY SOLDIER DURING DEPLOYMENT. SOLDIERS ARE AUTH SPECIAL STORAGE OF HHG AND ONE POV IF REQUIRED IAW JFTR PARA U4770. TRAVEL BY POV IS NOT AUTHORIZED. TRANSPORT OF PERSONAL WEAPONS IS NOT AUTHORIZED.
- (b) YOU WILL BRING ONLY THOSE ITEMS SPECIFIED BY CDR, US TOTAL ARMY PER CMD, OR OTHER APPROPRIATE AUTHORITY. YOU WILL BE PROVIDED A LIST OF THOSE ITEMS FM YOUR SERVICING PERS CENTER/COMPANY.
- (c) SOLDIER READINESS PROCESSING WILL BE ACCOMPLISHED PRIOR TO DEPARTURE FROM LOSING INSTALLATION/HOME STATION PER AR 600-8-101, CHAP 4. SOLDIERS WILL HANDCARRY OUTPROCESSING PACKET, MPRJ ALONG WITH ASSOC TRF DOCS AND RECORDS, AND DEPLOYMENT PACKET TO GAINING PSC.
- (d) GOVT MESS AND QTRS ARE PROVIDED. ALL THREE GOVT MEALS ARE AVAILABLE. GOVT QTRS AND DINING FAC WILL BE USED WHEN AVAILABLE. WHEN GOVT QTRS AND DINING FAC ARE NOT AVAILABLE, SOLDIER MUST OBTAIN A STATEMENT OF NONAVAILABLE FOR REIMBURSEMENT. PER DIEM PAYABLE IS \$2.00 PER DAY FOR CONUS AND \$3.50 PER DAY OCONUS. PER DIEM WILL NORMALLY BE PAID FOR THE TVL TO GAINING STATION OR REPLACEMENT ACT UNLESS PROHIBITED BY TVL CIRCUMSTANCES.
- (e) DURING PERIOD OF DEPLOYMENT, GAINING/DEPLOYED UNIT CDR HAS RESPONSIBILITY FOR PERSONNEL SERVICE SUPPORT TO INCLUDE AWARDS AND DECORATIONS, UCMJ AND ALL OTHER FORMS OF PERSONNEL AND LEGAL ADMINISTRATION AUTHORITY EXCEPT RESERVE COMPONENT PROMOTIONS.
- (f) FOR ACTIVE DUTY SOLDIERS, INCLUDING AGR, VARIABLE HOUSING ALLOWANCE (VHA) IS BASED UPON THEIR PERMANENT DUTY STATION. VHA IS BASED ON THEIR PRINCIPLE PLACE OF RESIDENCE WHEN CALLED OR ORDERED TO THE TOUR OF ACTIVE DUTY IF DENIED MOVEMENT OF DEPENDENTS AND HHG.

Additional instructions (cont):

- (g) SOLDIER MAY SUBMIT INTERIM TVL VOUCHER IF OTHERWISE ENTITLED TO PER DIEM/ TRAVEL. CARE SHOULD BE TAKEN TO KEEP ALL DOS TO SPT PMTS/REQ FOR PMTS. DUTY UNIFORM WILL BE BDUS. SOLDIERS MUST RECEIVE ALL REQUIRED IMMUNIZATIONS FOR DEPLOYMENT.
- (h) UNITS AND SOLDIERS WILL BE ORDERED TO ACTIVE DUTY INITIALLY FOR NOT MORE THAN ONE YEAR. UNDER [REDACTED] THE SECRETARY OF THE ARMY MAY DIRECT UP TO TWO YEARS.

I am responding to Commissioner Stamper's request for comments on a request to grant benefits to a temporary employee at the Sheriff's Department.

In the Personnel Policy Manual, it states:

"Temporary employees are non-benefitted and therefore do not accrue vacation leave."

This quote can be found in Section 2.4 Vacation Leave, second paragraph.

I also checked with Mark Stone for a historical perspective and he doesn't recall the county granting benefits to temporary employees. He suggested that I check with June, so I contacted the Auditor's Office. Sue Lake doesn't recall anyone receiving benefits while being employed on a temporary status, she will check with June to confirm.

Sue did mention that Public Works has gone back on Wendy Lister and Sarah Bailey and given them leave retroactive to their date of hire as a temporary employee.
