Our Information Technology department has been experiencing continuous problems from our toner contract with Office Source. Our contract requires delivery within two days, and frequently orders are taking five days or longer to arrive. In addition, the boxes continuously arrive damaged.

The Purchasing department notified Office Source by letter on December 8, 2003 informing them of their non-compliance regarding delivery time and their use of substituting remanufactured toner cartridges. However, we still receive shipments late and damaged boxes.

Purchasing requests approval from the commission to cancel this contract effective June 30, 2004. We will re-bid this month in order to have another contract in place on July 1, 2004.

Dear Mr. Ashby:

The purpose of this letter is to inform you of Office Sources' non-compliance with contract number 64-30SEP03 – Toner Cartridges Term and Supply. The Boone County Information Technology department has experienced multiple problems with their orders since this contract has been in place.

The order placed on November 20, 2003 was not received until November 26, 2003. This is in violation of the following paragraph of the contract:

4.10. Delivery after Receipt of Order: 2 Days

When this order arrived, the cartridges appeared damaged. The boxes were crushed and open on the seams.

The order that was received on December 8, 2003 for the IBM 4317 was labeled *Remanufactured Toner Cartridge*. This is in violation of the following paragraph of the contract:

2.3.2. All toner cartridges must be new. No refurbished or recycled toner cartridges are acceptable.

While we appreciate your help to try to rectify the problems, we are finding the continuous problems to be unacceptable for Boone County. Should we continue to experience violations of this contract, we may exercise our option to terminate this agreement due to material breach of the terms of this agreement. #### COMPUTER AND SERVER MAINTENANCE SERVICES TERM AND SUPPLY

**THIS AGREEMENT** dated the <u>4</u> day of <u>MAN</u> 2004 is made between Boone County, Missouri, a political subdivision of the State of Missouri through the Boone County Commission, herein "County" and **Integrated Solutions Group**, herein "Contractor."

**IN CONSIDERATION** of the parties performance of the respective obligations contained herein, the parties agree as follows:

1. Contract Documents - This agreement shall consist of this Purchase Agreement for Computer and Server Maintenance Services Term and Supply, County of Boone Request for Bid for Computer and Server Maintenance Services Term and Supply, bid number 17-13APR04 Introduction and General Conditions of Bidding, Primary Specifications, Response Presentation and Review, the un-executed Response Form, Exhibit A, Standard Terms and Conditions, Addendum #1, as well as the Contractor's bid response dated April 12, 2004 and executed by Terry Thornsberry on behalf of the Contractor. All such documents shall constitute the contract documents which are attached hereto and incorporated herein by reference. Service or product data, specification and literature submitted with bid response may be permanently maintained in the County Purchasing Office bid file for this bid if not attached. In the event of conflict between any of the foregoing documents, Introduction and General Conditions of Bidding, Primary Specifications, Response Presentation and Review, the un-executed Response Form, Exhibit A, Standard Terms and Conditions, and Addendum #1, shall prevail and control over the Contractor's bid response.

2. Contract Duration - This agreement shall commence on May 1, 2004 above and expire on April 30, 2005 and subject to the provisions for termination specified below. This agreement may be extended beyond the expiration date by order of the County for four additional one year periods subject to the pricing clauses in the Contractor's bid response and thereafter on a month to month basis in the event the County is unable to re-bid and/or award a new contract prior to the expiration date after exercising diligent efforts to do so or not; provided, however, that from and after the expiration date of this agreement any annual extensions thereof.

**3.** Services - The County agrees to purchase from the Contractor and the Contractor agrees to supply the County equipment maintenance and repair services in conformity with the contract documents for the prices set forth in the Contractor's bid response, as needed and as ordered by County.

- c. If appropriations are not made available and budgeted for any calendar year.






