

Now on this day the County Commission of the County of Boone does hereby adopt the provisions of 139.052, RSMo relating to the payment of property taxes by installments to the payment of neighborhood improvement district assessments as permitted in section 67.463.5, RSMo. The payment of neighborhood improvement district assessments by installment shall be restricted to the current tax bills for each individual annual assessment not paid by mortgage companies. Delinquent taxes or assessments are not eligible for the installment payment plan. The installment payment plan shall be effective for the 2007 property tax year and thereafter and shall be administered by the County Collector to insure the efficient and accurate collection of neighborhood improvement district assessments and compliance with any current or future statutory provisions relating to tax collection.


