I am requesting your approval to replace the current benefitted Accountant Position (Pos #742) in the Treasurer's Office with a benefitted Senior Account Specialist Position (Pos #461). I realize that this request is reversing changes that were made last year, returning to the previous staffing arrangement. I have reviewed the work requirements and responsibilities for this position and believe that the Senior Account Specialist is a more appropriate classification for the work load at this time. I hope to fill this vacancy in the near future.

After the total cost for temporary services is known, I plan to bring you a subsequent budget reclassification request to use some of the unused Class 1 Budget to cover both the cost of the temp personnel used and some other costs that have resulted from my transition to the Treasurer's Office (new envelopes, stamps, etc). At that time, I would ask that you consider restoring some of the other budget categories previously reduced to allow for the Accountant position classification change. There is very little budgeted for Dues, Travel, & Training compared to prior years. I anticipate all requested changes to be budget neutral, only reallocating the budget to different classes.
