Resolution to Adopt the Northeast Columbia Area Plan (NECAP)

Whereas, the Columbia Public School Board of Education selected a site for a new high school outside the municipal limits of Columbia on St. Charles Road; and

Whereas, the area in the vicinity of the selected site includes a mix of rural residential and agricultural land uses; and

Whereas, the governing bodies of Boone County and the city of Columbia believe that locating a high school in such an area will impact the growth and development of the area; and

Whereas, the Boone County Commission requested the Planning and Zoning Commission to engage the Columbia Planning and Zoning Commission in evaluating future land use for the area in the vicinity of the new high school site; and

Whereas the two Planning and Zoning Commissions endeavored to study an area roughly bounded by Interstate 70 highway on the south side, Mexico Gravel Road on the north side, Lake of the Woods Road on the west and one-half mile east of State Highway Z on the east; and

Whereas, the two Planning and Zoning Commissions conducted a number of open houses to solicit public input on the potential future development of the land within the study area; and

Whereas, the two Planning and Zoning Commissions incorporated public comment in an extensive future land use plan known as the Northeast Columbia Area Plan (NECAP); and

Whereas, the Boone County Planning and Zoning Commission recommended that the Northeast Area Columbia Area Plan (NECAP) be adopted as a sub-plan of the Boone County Master Plan at their October 15, 2009 regular meeting; and
