





NOTICE OF FEDERAL INTEREST

On the 4th day of January, 2018, the **County of Boone, Missouri, Grantor**, hereby acknowledges that the **Health Resources and Services Administration**, a division of the U.S. Department of Health and Human Services, **Grantee**, awarded Grant No. CD8DCS29671 to the Family Health Center of Boone County, Inc., a tenant of the Grantor. The grant provides Federal funds for a 5-operatorial dental unit at Unit #2 of the Columbia/Boone County Health Department Condominium. Grantee's mailing address is: c/o Columbia/Boone County Health Department, 1001 W. Worley, Columbia, MO 65203. Said property can be more particularly described as follows:

Unit #2 of the Columbia/Boone County Health Department Condominium as shown by a Condominium Plat recorded at Book 2555, Page 43, Boone County Records.


The Notice of Award for this grant includes conditions on use of the improvements located at the aforementioned property and provides for a continuing Federal interest in the property for the duration specified herein. Specifically, the property may not be (1) used for any purpose inconsistent with the statute and any program regulations governing the award under which the property was acquired; (2) mortgaged or otherwise used as collateral without the written permission of the Associate Administrator, Office of Federal Assistance Management (OFAM), Health Resources and Services Administration (HRSA), or designee; or (3) sold or transferred to another party without the written permission of Associate Administrator, Office of Federal Assistance Management (OFAM), Health Resources and Services Administration (HRSA), or designee. These conditions are in accordance with the statutory provisions set forth in Title 45 CFR part 74 or 92 (as appropriate), the HHS Grants Policy Statement, and other terms and conditions of award.

These grant conditions and requirements cannot be nullified or voided through a transfer of ownership. Therefore, advance notice of any proposed change in usage or ownership must be provided to the Associate Administrator, Office of Federal Assistance Management (OFAM), Health Resources and Services Administration (HRSA), or designee.


This Notice and the related federal interest shall both expire no later than June 30, 2029, and thereafter this Notice and the federal interest shall be null and void.
