**CONTRACT AMENDMENT NUMBER ONE
FOR

The Agreement dated the 1st day of June, 2016 (Boone County Commission Order 237-2016) made by and between Boone County, Missouri and **Advanced Correctional Healthcare, Inc.** for and in consideration of the performance of the respective obligations of the parties set forth herein, is amended as follows:

1. The contract period shall be renewed **June 1, 2019 through May 31, 2020.** All terms and conditions as established in the original contract shall remain the same and apply hereto. Pricing for the contract period starting June 1, 2019 shall be governed by the attached letter dated January 28, 2019 from Emma Caldwell, Controller, for Advanced Correctional Healthcare, Inc. The contract will continue to extend at the same pricing on a month to month basis until 60 days written notice is given by either party.

IN WITNESS WHEREOF the parties through their duly authorized representatives have executed this agreement on the day and year first above written.





I hope you are doing well. Our contract is scheduled to renew on 6/1/19. At that time, the contract price will increase by 3.00%. The new contract price will be \$648,813.54. To compare, the Consumer Price Index for Hospital and Related Services - Medical Care's 12-month data (ending December 2018) is 4.20%. The per diem rates for variances in the average daily population will be \$0.69 (county) and \$0.27 (non-county).
