

## FINDING OF PUBLIC NUISANCE AND ORDER FOR ABATEMENT

Now on this 13 day of September 2022, the County Commission of Boone County, Missouri met in regular session and entered the following findings of fact, conclusions of law and order for abatement of nuisance:

### Findings of Fact and Conclusions of Law

The County Commission finds as fact and concludes as a matter of law the following:

1. The Boone County Code of Health Regulations (the "Code") are officially noticed and are made a part of the record in this proceeding.
2. The City of Columbia/Boone County Health Department administrative record is made a part of the record in this proceeding and incorporated herein by reference. In addition, any live testimony of the official(s) of the department and other interested persons are made a part of the record in this proceeding.
3. A public nuisance exists described as follows: \*trash, rubbish, garbage, broken furniture and unlicensed, derelict, inoperable vehicles on the premises.
4. The location of the public nuisance is as follows 1603 E Tower Dr, Columbia, MO, a/k/a parcel# 12-417-19-01-039.00 01, Gas Light Acres Blk 2 Lot 17, Section 19, Township 49, Range 12 as shown by deed book 5624 page 0044, Boone County
5. The specific violation of the Code is: trash, rubbish, garbage and broken furniture and unlicensed, derelict, inoperable vehicles in violation of section 6.5 of the Code.
6. The Health Director's designated Health Official made the above determination of the existence of the public nuisance at the above location. Notice of that determination and the requirement for abatement was given in accordance with section 6.10.1 of the Code on the 24 day of June 2022, to the property owner.
7. The above described public nuisance was not abated. As required by section 6.10.2 of the Code, the property owner was given notice of the hearing conducted this date before the Boone County Commission for an order to abate the above nuisance at government expense with the cost and expense thereof to be charged against the above described property as a special tax bill and added to the real estate taxes for said property for the current year.
8. No credible evidence has been presented at the hearing to demonstrate that no public nuisance exists or that abatement has been performed or is unnecessary;

**SUBJECT:** Applications for State Homeland Security Program Grant

Boone County OEM is seeking to apply for the FY 2022 State Homeland Security Program (SHSP) Enhancing Community Preparedness and Resilience (ECPR) Notice of Funding Opportunity (NFO) to support the development of our Boone County Community Emergency Response Team (CERT). This grant will help increase the ability of our volunteers to aid their fellow citizens prior to the arrival of professional first responders after a disaster, such as a terrorist attack or weather event. By helping us expand the trained citizenry in Boone County, this program will help us meet the core capabilities of community resilience and mass care services.

To accomplish this the ECPR grant request will include supplies and equipment necessary to train and equip new and current CERT team members to a higher level, particularly focusing on mass care/casualty events where community resources tend to be overwhelmed. This equipment will be stored and maintained at the Boone County Office of Emergency Management and organized into sets and kits to facilitate ease of access for training events and rapid deployment for real world emergencies.

The NFO will be open until September 14<sup>th</sup> at 5:00 PM, at which point the application period will end. Funds have from September 1<sup>st</sup>, 2022, until August 31<sup>st</sup>, 2022, to be expended. ### **Introduction**

The Missouri Office of Homeland Security is pleased to announce the funding opportunity for the FY 2022 State Homeland Security Program (SHSP), Enhancing Community Preparedness and Resilience (ECPR). This state administered, but federally funded program, is made available through the Grants Programs Directorate (GPD) and National Preparedness Directorate (NPD) within the Federal Emergency Management Agency (FEMA).

### **Program Description**

SHSP ECPR assists state and local efforts to build, sustain, and deliver capabilities necessary to prevent, prepare for, protect against, and respond to, acts of terrorism through projects that enhance community preparedness and resilience in Missouri.

Individual citizens and volunteer responders, such as Community Emergency Response Teams (CERT), are often the first on the scene after a terrorist attack. The ability of these volunteers to provide assistance to their fellow citizens prior to the arrival of professional first responders is paramount to a community's resilience. Projects must bolster community preparedness and resilience by investing in local, community-driven capabilities.

## **Objective**

The objective of the FY 2022 SHSP is to fund state and local efforts to prevent terrorism and prepare the Nation for threats and hazards that pose the greatest risk to the security of the United States.

## **Priorities**

Given the evolving threat landscape, it is incumbent upon DHS/FEMA/OHS to continuously evaluate the national risk profile and set priorities that help ensure appropriate allocation of scarce security dollars. In assessing the national risk profile for FY 2022, six priority areas attract the most concern. The following are the six priority areas for FY 2022:

1. Enhancing the protection of soft targets/crowded places;
2. Enhancing information and intelligence sharing
3. Combating domestic violent extremism
4. Enhancing cybersecurity
- 5. Enhancing community preparedness and resilience**
6. Enhancing election security

**This grant program focuses only on the national priority of enhancing community preparedness and resilience and must align to one of the Core Capabilities listed below:**

- Planning
- Public information and warning
- Community resilience
- Risk management for protection programs and activities
- Mass care services
- Intelligence and information sharing
- Risk and disaster resilience assessment
- Long term vulnerability reduction

DHS/FEMA/OHS strongly encourages SHSP subrecipients to participate in the THIRA (Threat and Hazard Identification and Risk Assessment)/SPR (Stakeholder Participation Report) process and prioritize grant funding to support closing capability gaps or sustaining capabilities that address national priorities and/or support enduring needs.

**Period of Performance:** 24 months

**Projected Period of Performance Start Date:** September 1, 2022

**Projected Period of Performance End Date:** August 31, 2024

**Funding Instrument:** Grant

**Allowable Amount:** \$25,000 maximum award per applicant agency

## **Eligible Applicants:**

The following Missouri entities are eligible to apply for the FY 2022 SHSP ECPR funding opportunity:

- Local units of government
- Nongovernmental organizations, quasi-governmental organizations, and nonprofit organizations

## **Ineligible Applicants**

- Entities located within the geographical boundaries of the St. Louis Urban Area Security Initiative (UASI), which includes the Missouri Counties of Franklin, Jefferson, St. Charles, St. Louis and St. Louis City are **NOT** eligible applicants.
- Entities located within the geographical boundaries of the Kansas City Urban Area Security Initiative (UASI), which includes the Missouri counties of Jackson, Cass, Platte, Clay, and Ray are **NOT** eligible applicants.
- State Agencies are **NOT** eligible applicants.

## **Other Eligibility Criteria**

### **National Incident Management System (NIMS) Implementation**

Prior to allocation of any Federal preparedness awards in FY 2022, subrecipients must ensure and maintain adoption and implementation of NIMS. The list of objectives used for progress and achievement reporting is on FEMA's website at <https://www.fema.gov/emergency-managers/nims/implementation-training>. Please see the [Preparedness Grants Manual](#) for more information on NIMS.

### **Emergency Management Assistance Compact (EMAC) Membership**

In support of the National Preparedness Goal (the Goal), SHSP subrecipients must belong to, be in, or act as a temporary member of EMAC, except for American Samoa and the Commonwealth of the Northern Mariana Islands, which are not required to belong to EMAC at this time. All assets supported in part or entirely with FY 2022 HSGP funding must be readily deployable and NIMS-typed when possible to support emergency or disaster operations per existing EMAC agreements. In addition, funding may be used for the sustainment of core capabilities that, while they may not be physically deployable, support national response capabilities as defined under the Mitigation Mission Area of the Goal, and fusion centers.

By submitting an application, applicants agree to comply with the requirements of this NOFO and the terms and conditions of the award, should they receive an award.

Applications will only be accepted through the Missouri Department of Public Safety (DPS) online WebGrants System.

As part of the FY 2022 SHSP ECPR application, each eligible applicant must complete all application forms and provide all required documents:

- 1. Contact Information Form**
- 2. SHSP Project Package**
- 3. Budget**
- 4. Named Attachments**
  - a. Audit/Financial Statement (REQUIRED)**
  - b. Federal Fund Schedule (REQUIRED, if not included in Audit)**
  - c. Quote or Cost Basis**
  - d. Training Request Form**
  - e. Other Supporting Information**

Each application must only include one project, and all requested funding in the application must be directly associated to that specific project.

### **SHSP Funding Guidelines**

Subrecipients must comply with all the requirements in 2 C.F.R. Part 200 (*Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards*). Funding guidelines established within this section support the five mission areas—Prevention, Protection, Mitigation, Response, and Recovery—and associated core capabilities within the Goal. Allowable projects made in support of the Enhancing community preparedness and resilience national priority, must have a nexus to terrorism preparedness and fall into the categories of planning, organization, exercises, training, or equipment aligned to closing capability gaps or sustaining capabilities identified in the State THIRA/SPR.

## **Multiple Purpose or Dual-Use of Funds**

For SHSP, many activities that support the achievement of core capabilities related to the national priorities and terrorism preparedness may simultaneously support enhanced preparedness for other hazards unrelated to acts of terrorism. However, all SHSP funded projects must assist subrecipients in achieving core capabilities related to preventing, preparing for, protecting against, or responding to acts of terrorism per section 2008(c) of the *Homeland Security Act of 2002* [[6 U.S.C. § 609\(c\)](#)].

## **Funding Restrictions and Allowable Costs:**

All costs charged to awards covered by this NOFO must comply with the Uniform Administrative Requirements, Cost Principles, and Audit Requirements at [2 C.F.R. Part 200](#), unless otherwise indicated in the NOFO, the terms and conditions of the award, or the [Preparedness Grants Manual](#). This includes that costs, among other requirements, must be incurred, and products and services must be delivered, within the period of performance of the award. See [2 C.F.R. § 200.403\(h\)](#) (referring to budget periods, which for FEMA awards under this program is the same as the period of performance).

Federal funds made available through this award may be used for the purpose set forth in this NOFO, the [Preparedness Grants Manual](#), and the terms and conditions of the award and must be consistent with the statutory authority for the award. Award funds may not be used for matching funds for any other federal awards, lobbying, or intervention in federal regulatory or adjudicatory proceedings. In addition, federal funds may not be used to sue the Federal Government or any other government entity. See the [Preparedness Grants Manual](#) for more information on funding restrictions and allowable costs.

### **1. Prohibitions on Expending FEMA Award Funds for Covered Telecommunications Equipment or Services**

Recipients and subrecipients of FEMA federal financial assistance are subject to the prohibitions described in section 889 of the [John S. McCain National Defense Authorization Act for Fiscal Year 2019 \(FY 2019 NDAA\)](#), Pub. L. No. 115-232 (2018) and 2 C.F.R. §§ 200.216, 200.326, 200.471, and Appendix II to 2 C.F.R. Part 200. Beginning August 13, 2020, the statute – as it applies to FEMA recipients, subrecipients, and their contractors and subcontractors – prohibits obligating or expending federal award funds on certain telecommunications and video surveillance products and contracting with certain entities for national security reasons.

Guidance is available at [Prohibitions for Expending FEMA Award Funds for Covered Telecommunications Equipment or Services \(Interim\) #405-143-1, or superseding document](#).

Additional guidance is available at [Contract Provisions Guide: Navigating Appendix II to Part 200 – Contract Provisions for Non-Federal Entity Contracts Under Federal Awards \(fema.gov\)](#).

**Effective August 13, 2020**, FEMA recipients and subrecipients **may not** use any FEMA funds under open or new awards to:

- a. Procure or obtain any equipment, system, or service that uses covered telecommunications equipment or services as a substantial or essential component of any system, or as critical technology of any system;
- b. Enter into, extend, or renew a contract to procure or obtain any equipment, system, or service that uses covered telecommunications equipment or services as a substantial or essential component of any system, or as critical technology of any system; or
- c. Enter into, extend, or renew contracts with entities that use covered telecommunications equipment or services as a substantial or essential component of any system, or as critical technology as part of any system.

#### **I. Replacement Equipment and Services**

FEMA grant funding may be permitted to procure replacement equipment and services impacted by this prohibition, provided the costs are otherwise consistent with the requirements of the NOFO and the [Preparedness Grants Manual](#).

#### **II. Definitions**

Per section 889(f)(2)-(3) of the FY 2019 NDAA and 2 C.F.R. § 200.216, covered telecommunications equipment or services means:

- i. Telecommunications equipment produced by Huawei Technologies Company or ZTE Corporation, (or any subsidiary or affiliate of such entities);
- ii. For the purpose of public safety, security of Government facilities, physical security surveillance of critical infrastructure, and other national security purposes, video surveillance and telecommunications equipment produced by Hytera Communications Corporation, Hangzhou Hikvision Digital Technology Company, or Dahua Technology Company (or any subsidiary or affiliate of such entities);
- iii. Telecommunications or video surveillance services provided by such entities or using such equipment; or
- iv. Telecommunications or video surveillance equipment or services produced or provided by an entity that the Secretary of Defense, in consultation with the Director of National Intelligence or the Director of the Federal Bureau of Investigation, reasonably believes to be an entity owned or controlled by, or otherwise connected to, the People's Republic of China.

Examples of the types of products covered by this prohibition include phones, internet, video surveillance, and cloud servers when produced, provided, or used by the entities listed in the definition of “covered telecommunications equipment or services.” See 2 C.F.R. § 200.471.

## **2. Allowable Costs**

This grant only allows projects that enhance the preparedness and resilience of Missouri’s communities. Examples of allowable projects include those that support establishing, training, and maintaining Community Emergency Response Teams (CERT), Medical Reserve Corp (MRC), Volunteer Organizations Assisting in Disasters (VOAD), and other community response teams.

Examples of allowable costs include procurement of appropriate tools, equipment, and training to support the proposed community preparedness and resilience project. Costs across all categories of POETE (Planning, Organization, Equipment, Training, and Exercise) are allowable.

Equipment must be deployable locally, regionally, and/or nationally and made available to other entities through a Memorandum of Understanding, when requested, and not in use by the awarded agency.

The 21 allowable prevention, protection, mitigation, response, and recovery equipment categories for HSGP are listed on the [Authorized Equipment List](#) (AEL). Some equipment items require prior approval from DHS/FEMA/OHS before obligation or purchase of the items. Please reference the grant notes for each equipment item to ensure prior approval is not required or to ensure prior approval is obtained if necessary.

Unless otherwise stated, all equipment must meet all mandatory regulatory and/or FEMA/OHS-adopted standards to be eligible for purchase using these funds. In addition, subrecipients will be responsible for obtaining and maintaining all necessary certifications and licenses for the requested equipment. Investments in emergency communications systems and equipment must meet applicable [SAFECOM Guidance](#). Such investments must be coordinated with the SWIC and the State Interoperability Governing Body (SIGB) to ensure interoperability and long-term compatibility. All radios must meet the Missouri Department of Public Safety, Office of the Director Criminal Justice/Law Enforcement (CJ/LE) Unit, Office of Homeland Security (OHS) [Radio Interoperability Guidelines](#). The Missouri Interoperability Center (MIC) will review all communications equipment applications to ensure they comply with the [Radio Interoperability Guidelines](#). **Applications that do not meet these guidelines will not be eligible for funding.**

Unless otherwise stated, all equipment must meet all mandatory regulatory and/or DHS/FEMA/OHS-adopted standards to be eligible for purchase using these funds. In addition, subrecipients will be responsible for obtaining and maintaining all necessary certifications and licenses for the requested equipment.

## **Unallowable Costs**

- Per FEMA policy, the purchase of weapons and weapon accessories, including ammunition, is not allowed with HSGP funds.
- Grant funds may not be used for the purchase of equipment not approved by DHS/FEMA/OHS. Grant funds must comply with [FEMA Information Bulletin 426](#) and may not be used for the purchase of the following equipment: firearms; ammunition; grenade launchers; bayonets; or weaponized aircraft, vessels, or vehicles of any kind with weapons installed.
- Unauthorized exercise-related costs include:
  - Reimbursement for the maintenance or wear and tear costs of general use vehicles (e.g., construction vehicles), medical supplies, and emergency response apparatus (e.g., fire trucks, ambulances).
  - Equipment that is purchased for permanent installation and/or use, beyond the scope of the conclusion of the exercise (e.g., electronic messaging sign).

### **Administrative and National Police Requirements**

In addition to the requirements in this section and elsewhere in this NOFO, FEMA/OHS may place specific terms and conditions on individual awards in accordance with 2 C.F.R. Part 200.

### **Ensuring the Protection of Civil Rights**
