BOONE COUNTY, MISSOURI AND BOONE COUNTY LOCAL EMERGENCY PLANNING COMMITTEE (LEPC)

GRANT ASSET TRANSFER COOPERATIVE AGREEMENT

THIS AGREEMENT, dated this 27 day of July, 2023, is made and entered into by and between the parties, Boone County, Missouri, a political subdivision of the State of Missouri, herein "Boone County" and the Boone County Local Emergency Planning Committee (LEPC), a committee established and authorized per RSMo Secs. 292.600-292.625, herein "LEPC".

WHEREAS, the Missouri Emergency Response Committee, herein "MERC", in cooperation and collaboration with the Missouri State Emergency Management Agency, herein "SEMA", made certain grant funding available to local LEPCs; and

WHEREAS, in order to be considered for these grant funds LEPCs needed to collaborate with their local Emergency Management offices; and

WHEREAS, Boone County's LEPC requested that Boone County, by and through its Emergency Management department, apply for these grant funds on LEPC's behalf; and

WHEREAS, Boone County Office of Emergency Management made application for LEPC through the SEMA grant portal and was successful in obtaining grant funding for LEPC; and

WHEREAS, Boone County, at LEPC's request, acquired certain assets and services consisting of certain training courses or studies, herein "services", with said grant funding for LEPC's use; and

WHEREAS, the parties now wish to document the transfer of those assets and services, which have been received by Boone County and/or LEPC, to LEPC for LEPC's further use and deployment; and

WHEREAS, the citizens of Boone County will benefit from LEPC's access to these grant-acquired assets and services as facilitated by Boone County; and

WHEREAS, this Cooperative Agreement (hereinafter referred to as "Agreement") memorializes the parties' understanding regarding the transfer of these assets and services to LEPC.

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants and agreements in this Agreement, the parties agree as follows:

- 1. PURPOSE. The purpose of this Agreement is to facilitate the receipt of and continued ownership by LEPC of certain items of personal property and the receipt of certain services acquired by Boone County with the successful grant funding from MERC. Such items and services are enumerated in Exhibit A which is attached hereto and is incorporated as part of this Agreement.
- 2. BOONE COUNTY AGREEMENTS. Boone County, having facilitated the purchase of the above-described assets and services with the successful grant funds, stands ready to deliver these assets to LEPC along with documentation concerning their purchase from the applicable vendors. Boone County will have no right, title, or interest in the assets or services after pick-up or consumption by LÉPC, nor shall Boone County be responsible for tracking, maintaining, insuring, or disposing of said assets or services.

3. **LEPC AGREEMENTS.**

- a. LEPC will pick up the transferred assets from the Boone County Office of Emergency Management as soon as practicable and will execute this agreement acknowledging receipt of the same.
- b. Although these are new assets, LEPC will accept the transferred assets from Boone County on an "as-is" basis and pursue any warranty, repair, or other issues which may arise directly with the selling vendors.
- LEPC will place these assets in service for LEPC purposes for so long as
 LEPC deems it appropriate.
- d. LEPC shall make use of such services as are authorized under the grant agreement to be transferred to and used by LEPC and its members.
- 4. **ASSIGNMENT.** Neither party may assign or transfer any of its rights or obligations under this Agreement to any other person or entity without the prior, written consent of the other party.
- 5. **SOLE BENEFIT OF PARTIES.** This Agreement is for the sole benefit of the parties to this agreement only, and nothing in this Agreement is intended to confer any rights or remedies on any other party.
- 6. RELATIONSHIP OF PARTIES. Nothing in this Agreement shall be deemed or construed by the parties, nor by any other party, as creating the relationship of principal and agent, or of partnership, or of joint venture, between the parties to this Agreement.
- 7. **GOVERNING LAW AND VENUE.** This Agreement shall be governed by the laws of the State of Missouri, and any action relating to the same shall be brought in the Circuit Court of Boone County, Missouri.

- 8. **BINDING ON SUCCESSORS.** The covenants, agreements, and obligations herein contained shall extend to, bind, and inure to the benefit of the parties hereto and their respective successors and approved assigns.
- 9. **COUNTERPARTS.** This Agreement may be executed by the parties in several counterparts, each of which shall be deemed an original instrument.
- 10. **COMPLETE AGREEMENT.** All negotiations, considerations, representations, and understandings between the parties are incorporated herein, shall supersede any prior agreements, and may be modified or altered only in a writing signed by the parties hereto.
- 11. AUTHORITY OF SIGNATORIES. Each of the persons signing this Agreement on behalf of either party represents that he/she has been duly authorized and empowered, by order, ordinance, or otherwise, to execute this Agreement and that all necessary action on behalf of said party to effectuate said authorization has been taken and done.
