Shall the Board of Education of Southern Boone County R-I School District be authorized to increase the operating property tax levy of the District by \$0.40 per one hundred dollars of assessed valuation for the purpose of paying general operating expenses and costs of capital improvements, including constructing, furnishing and equipping a new wing to the Primary School and hiring additional staff to maintain lower teacher to student ratios?

If this question is approved, the adjusted operating tax levy of the District is estimated to increase by \$0.40 from the current operating tax levy of \$3.6585 to \$4.0585 per one hundred dollars of assessed valuation.
