# **BOONE COUNTY PLANNING & ZONING COMMISSION**

Ten-member Board to include one citizen from an unincorporated area of each Township in Boone County and the County Engineer. The Board meets the second Thursday of each month at 5:30PM for a work session and the third Thursday of each month at 7:00PM for a regular session. Special meetings may be called as needed. All meetings are held in the Roger B. Wilson Boone County Government Center Chambers. The board advises the County Commission on matters of land use. (**Term – 4 years**) **Three Vacancies**; **1 Columbia Township** term expires 12/31/2027 or 4 years from appointment; **2** terms expiring 2028-04-30 or 4 years from appointment.

#### BOONE COUNTY INDUSTRIAL DEVELOPMENT AUTHORITY (IDA)

The IDA is governed by a nine-member board that is appointed by the Boone County Commission. The IDA facilitates the issuance of tax-free industrial development bonds for the development of commercial, industrial, agricultural and manufacturing facilities in the county. Members of the IDA must be duly qualified electors of and taxpayers in the county or municipality. No member shall be an officer or employee of the county or municipality. Members shall be a resident taxpayer for at least five years prior to their appointment. No less than three members of the Board shall reside in unincorporated areas of Boone County. (**Term – 6 years**) **Two Vacancies**; expiring 3/31/30, or 6 years from appointment.

#### VICIOUS DOG ADVISORY BOARD

Advisory board consisting of persons appointed by the Boone County Commission which evaluates evidence concerning dogs which are claimed to be vicious and makes a recommendation of their classification and disposition to the Health Department Director. The Board shall consist of five members, one licensed veterinarian, one animal control officer, one member from the Boone County Board of Health, one member from the public with a working knowledge of dogs, and one member from the public at large. The Board will convene at the request of the Health Director. (**Term - 3 year**) <u>One</u> <u>Vacancy</u>; term expires 3/31/2027 or 3 years from appointment.

#### CHILDREN'S SERVICES BOARD

The board is composed of nine Boone County residents. Of particular importance is that Board members demonstrate experience in one of the following areas: Mental Health, healthcare administration, administrative experience with a Governmental or social service agency, a former eligible service recipient or a guardian of a former eligible service recipient, legal experience, accountant/finance. The board in partnership with the Boone County Commission is charged with making Boone County a better and healthier community through the provision of services to protect the well-being and safety of children under the age of nineteen and their families. The board will maximize positive outcomes in a transparent, accountable fashion, recognizing that Boone County taxpayers are both stakeholders and beneficiaries of this program. (Term - 3 years) Three Vacancies; expiring 3/31/27.

## BOONE COUNTY BUILDING CODE COMMISSION

Four-member Board and one Voting County Commissioner. The Board is appointed by the County Commission to advise them on matters pertaining to the building code. The Building Code Commission meets on a periodic basis (as needed) to review code issues and review revisions to the model code. Prior to recommending the adoption of any code revisions to the County Commission, the Building Code Commission conducts three public hearings to provide an opportunity for citizen input. Meetings are held at the Boone County Government Center Chambers as needed. (**Term – 2 years**) **One Vacancy**; term expires 4/30/2026 or 2 years from appointment.

# **BOARD OF EQUALIZATION**

Eight-member Board which consists of the County Commission, a representative of the City of Columbia, and two citizens at large. The County Assessor and County Clerk, who is the Secretary of the Board are non-voting members. Citizens at large on the Board must possess a level of experience as a real estate broker, real estate appraiser, home builder, property developer, lending officer, or investor in real estate. The goal of the Board is to review tax assessments to be certain that each parcel is fairly assessed at the mandated proportion of market value. (**Term - 4 years**) **One Vacancy**; term expires 04-30-2028, or 4 years from appointment.

### **BOARD OF ADJUSTMENT**

Five-member board which meets the fourth Thursday of each month in the Boone County Government Center Chambers at 7:00 p.m. The Board reviews requests for a variance from the strict application of the Zoning and Subdivision Regulations. The board shall consist of five residents of the county, but not more than two shall be residents of the incorporated area of the county and not more than one may be a member of the County Zoning Commission. RSMo.64.870. (**Term – 4 years**) **One Vacancy**; terms expire 04-30-2028, or 4 years from appointment.

# BOONE COUNTY REGIONAL SEWER DISTRICT BOARD OF TRUSTEES

Five-member Board, including one County Commissioner. Meetings are held the third Tuesday of each month at 5:30 p.m. in the Boone County Commission Chambers. The Board is to assume long range responsibility for wastewater quality within Boone County, except for those facilities operated by a municipality, in order to improve and maintain the health and welfare of the residents of the County. Five trustees shall be appointed, the majority of whom shall reside within the boundaries of the district. RSMo. 204.300 (**Term - 5 years**) **One Vacancy**; partial term to run April 1, 2024 through January 31, 2028 to finish the term of the retiring trustee.
