- Fund Investments: Fund investment information was shared with the Boone County Commissioners. Commission liked the information and requested additional information to show the cost to run the department. The Auditor's Office is assisting in getting that information.
- Great Circle informative notice: Paula Fleming the President and CEO of Great Circle informed the Community Services Department (CSD) of negative news coverage in the STL area. No programs funded by the BCCSF are involved.
- Leadership changes: Several leadership changes within organizations has been observed over the past year.

# 5. Boone Indicators Dashboard Contract

Joanne reviewed the Scope of Work for Boone Indicators Dashboard (BID) in 2022. Cost for 2022 is \$13,250.
