## 2. Housing Study recommendations

- Becky Thompson announced that City of Columbia Management Fellow, Peyton Oliver, will lead
  the Housing Preservation Inventory Project. The project will analyze the City's and Boone
  County's data and then collaborate with local organizations to develop and expand the housing
  inventory. Planning and Zoning is continuing work on an ordinance to allow integration of small
  lots within all residential zoning districts. This ordinance is expected to be presented to the City
  Council later this summer.
- Becky also shared that she has accepted the role of Deputy City Counselor and will transition back to the law department within the next month. The city will initiate a search for her replacement as Director of Housing and Neighborhood Services. Becky expressed her intent to remain engaged with the group, and members thanked her for her significant contributions.

#### 3. Discussion of ADU's – Adrienne Stolwyck, Monarch Architecture

Adrienne provided an overview of Accessory Dwelling Units (ADUs), which are smaller, secondary residential units on a property that cannot be sold separately from the primary residence. Examples include units over garages, detached converted garages, or basement conversions—not to be confused with duplexes. It was noted that ADUs are currently not permitted in Boone County.
