a. Boone County school districts outreach update

3. Review Early Grade Literacy Survey Results

After reviewing the responses from the survey, the group discussed how the workgroup meetings could be improved.

- The workgroup discussed the need for the meetings to continue to be accessed through zoom.
- The workgroup discussed the possibility of dividing meetings up based on the topics regarding the age of the schoolchildren.
- The workgroup discussed topics about the work being done by current workgroup members and where the focus should be shifted to or remain moving forward.
- The workgroup discussed the potential for providing a method for individuals who are new to meetings to receive a short orientation to workgroup outside of meetings.
- The workgroup discussed clarifying what the workgroup should focus on would be helpful, noting review of data, previous discussions of potential collaboration around how to address waitlists, and connecting to parents across different school districts.
