# SEVERE WEATHER PREPAREDNESS

Severe weather including strong winds, hail, thunder, lightning, flooding, and tornadoes. Missouri and severe weather go hand in hand. It's important to discuss severe weather preparedness and safety before severe weather season to ensure we are all on the same page and safety is front of mind for all of us. The week of March 6th, Boone County, and the entire state, participate in Severe Weather Preparedness Week. Each day focusing on a different severe weather hazard. We use this week to educate our community and encourage everyone to participate in getting prepared for the season. A prepared community is a resilient community. Tuesday our office will be participating in the statewide tornado drill at 10am. At this time, the NOAA weather radios, and the outdoor warning siren system will be activated (weather permitting). Use this time to identify your safe place at your home and work.




Winter storms swept through the West and North United States resulting in nearly 1 million power outages while the Eastern and Southern parts of the United States experienced unseasonably high temperatures for February. East Palestine in Ohio is continuing to deal with environmental and health concerns after a train carrying hazardous materials derailed in their community and forced citizens to evacuate. This emergency is bringing attention to the current laws that regulate the Federal Emergency Management Agency (FEMA)'s ability to help local communities severely impacted by technological and environmental emergencies. In California, Oakland is dealing with a series of ransomware attacks shining light on the vulnerability of local governments to cyber threats. Unidentified Flying Objects (UFOs) were sited and shot down in the United States, China, and Russia last month.



## **RESOURCE CORNER**

Smart911 is an easy-to-use safety tool that is free to you. By setting up your Smart911 profile, you can share critical information with dispatchers in the event you call 9-1-1. In addition, you can opt-in to share your information with emergency managers so we can plan for any special needs your household may have and access those needs during a large-scale response. Lastly, you are able to opt-in to receive weather alerts and emergency notifications to enable you to stay informed.



## DO 1 THING

- Know how to respond safely when it is necessary to shelter in place or evacuate your home.
- Identify the best place to shelter in your home and practice going there with your household.
- Make an emergency kit for when you may need to shelter in place and a go-bag in the event you need to evacuate your home quickly.
- Identify alternative sheltering options for pets in the event you need to evacuate your home.
- Discuss safe places to shelter in the event you are outdoors when severe weather occurs.

# Brought to you by Boone County Office of Emergency Management

The mission of the Boone County Ready campaign is to enhance community preparedness, foster collaboration and build resilience by engaging our citizens in actively preparing for emergencies and disasters. The Boone County Office of Emergency Management wanted to provide the community with an opportunity to have a one-stop shop for becoming prepared for the hazards we face.

Here's how you can become #BooneCountyReady for severe weather hazards including

Here's how you can become #BooneCountyReady for severe weather hazards including lightning, hail, thunderstorms, tornadoes, heavy rain and flooding:

#### 1.BE INFORMED

Create a Boone County Ready, powered by Smart911, safety profile, opt-in for weather alerts, traffic alerts, emergency alerts and Boone County Ready non-emergency notifications. Purchase a battery-operated or hand crank NOAA weather radio for your emergency kt so you can stay aware if the other communication sources are down. Educate yourself and your household on safe places to shelter during the different severe weather hazards.



Talk to your household about where to shelter whether you are at home, work, school, or outdoors when severe weather is expected. Discuss where you will meet and how you will contact each other in the event cell phones are damaged or otherwise unavailable.

#### 3. BUILD A KIT

Have an emergency kit ready for each member of your household. If possible, store them in your safe place so they are easily accessible during severe weather. Consider packing a separate go-bag that is easy to carry should you need to evacuate your hom quickly.

#### 4. GET INVOLVED

Educate yourself on safe places at your home, school, and outdoor recreational spots you frequent for the various severe weather hazards. Attend CERT Basic Training, available in-person and online, to learn valuable skills that could help you keep your household and neighbors safe during and after an emergency.

# WHAT WE'VE BEEN UP TO

February went by fast, and with very little winter weather at that! We had an internal EOC tabletop exercise that we found to be very engaging and a great learning experience. Kudos to our Training & Exercise Specialist, Matt Brown, for putting that together and honing our EOC operations skills as a team. We had a surprise visit from our Presiding Commissioner, Kip Kendrick, earlier this month. He stopped by and joined us for our morning stand-up. For me, it was the greatest commission interaction I've had since Commissioner Justin Aldred let me take his photo in front of the balloon wall at our first Ready Festival. Photo included for your viewing pleasure.

Here's a very brief look into the everyday life of the OEM team and a few things we were working on throughout the short month of February.



Bart worked on administrative tasks to keep our office well-oiled and running. He answers all of the phone calls to the ECC, updates EOC computers, checks the OEM vehicles biweekly, pays the bills, and visits siren sites to see if they need any landscaping maintenance.

Paige has taken over the Continuity of Operations Plan (COOP) and has worked on it more this month. She is working on making it a simpler platform to understand before working with other Boone County employees and elected officials to complete the plan. She has been working with the American Red Cross to help develop emergency shelters for people displaced from their homes after a potential disaster in Boone County. She has also been expanding her knowledge on geographic information systems (GIS) to be able to work with and assist developing maps.

February was a busy month for Matt in the Training and Exercise world. Since it was American Heart Month, we hosted a CPR course for our CERT Team at our monthly meeting. We also facilitated the annual LEPC Exercise as a Functional Transportation HAZMAT Exercise with 2 other counties, Callaway and Cole. We also hosted an internal EOC Tabletop Exercise with our Emergency Management team. Finally, we started the process to get an incident command system instructor within our Emergency Management office.

Hannah continued to work on DR 4490 (COVID-19) and DR 4612 (2021 Flooding) public assistance grant management. In addition to maintaining the OEM and Boone County Ready social media pages, she also attended several public outreach meetings to discuss future plans for the office to strengthen our relationships with community partners. She coordinated and participated in media projects to promote the upcoming CERT Basic Training and met with various marketing partners to determine the best strategy for increasing citizen engagement and promoting preparedness in our community. She participated in the OEM's internal EOC tabletop exercise and attended a virtual Advanced Public Information Officer (APIO) training to further develop her communications skills during crisis. She is officially an APIO!

Sherril resigned from her part-time position with the OEM. We wish her the best of luck on her future endeavors.
