**SPECIFICATION CLARIFICATIONS:**

1. Replace the Bid Forms, pages 5.1 and 5.2, with the attached revised pages 5.1 and 5.2. These pages are revised to reflect the change from 18" Grouted Rip Rap to 18" Rip Rap. The new Bid Forms are printed on Green Paper. These should be turned in with your bid response.
