Bidders are hereby informed of the following clarifications and/or modifications to be made in the plans and project manual for the above referenced project.

1. Project Manual, Section 9.14 – FRP (Fiberglass Reinforced Polyester) Panels.

Clarification:

"Male Day Room No. 36A, Detention Rooms B09 thru B20 and Rooms No. 36B thru No. 36J - Install FRP panels directly to 5/8" gypsum board ceilings as shown by Wall Sections M/A4, A/A5 and B/A5. Delete references to lay-in ceiling panels as per Items 9.14.B.3. thru 9.14.B.5."

2. Project Manual, 15930: Duct Insulation – The intent of the specs is the following:

Clarifications: a.

a. All rectangular ductwork shall be internally insulated with ½", 2 lb./c.f. ductwork insulation.

- b. All round ductwork shall be externally insulated with 1" thick glass fiber insulation with vapor barrier."
