#### ADDENDUM #3

Bidders are reminded that receipt of this addendum should be acknowledged and submitted with the bidder's Response Form as instructed for this format of bidding.

Specifications for the above noted Request for Bid and the work covered thereby are herein modified as follows, and except as set forth herein, otherwise remain unchanged and in full force and effect:

- Project Manual, Division 1 General Project Requirements, Item 3, Bid Response Form.

  Substitute: "Contractors shall submit bids on the revised BID RESPONSE Form attached with this Addendum. Alternate No. 2 was added to the Bid Response Form. Alternate No. 2: Furnish and install all labor and material necessary to completely remove and dispose of asbestos mastic, leaving a clean bare concrete floor, in Rooms 113, 114, 115 and 116."
- 2. Drawings, First Floor Demolition Plan, Detail A/A1.
  - Clarification: "Base Bid: Contractors shall remove and dispose of vinyl tile, which contains residue from asbestos mastic, in Rooms 113, 114, 115 and 116. Note that after removal, all vinyl tile will have ACM residue on the back side. (The vinyl tile did not test positive for ACM. Only the black mastic tested positive for asbestos).
- 3. Drawings, Floor Plan, B/A1.

  Clarification: "Contractors shall install 3-5/8 metal studs at 16" o.c. and 5/8" gypsum board on the east side of the 3 hour fire-rated west wall in Rooms #113, 114 and 115 as per the drawings. (This will avoid 3 hr. firestopping for conduit and receptacle penetrations)."
- Drawings, Room Finish Schedule, Sheet A1.
   Clarification: "The existing ceiling grid shall remain in Rooms 117 and 120 thru 128. (Contractor shall install new 1 hr. rated ceiling tile and replace existing ceiling tile in these rooms)."
