

## NOTICE TO BIDDERS

**Boone County, Missouri is accepting sealed proposals for:**

**Project Construction:** Construction of approximately 7,960 linear feet of 24-foot wide asphaltic concrete or Portland cement concrete pavement on Olivet Road, overlaying the intersection of Olivet Road and Richland Road, and constructing approximately 425 feet of 24-foot wide asphaltic concrete or Portland cement concrete pavement on Richland Road. In association with the road construction the project will include clearing and grubbing, storm water drainage, fencing, guardrail installation, erosion control, and surface restoration. This project will also include the relocation of PWSD#9 waterline.

**Sealed bids, subject to the Instructions and General Conditions of Bidding, will be received at the Purchasing Office, Johnson Building, 601 E. Walnut, 2<sup>nd</sup> Floor, Room 209, Columbia, Missouri, 65201-4460 until 9:15 a.m. on March 16, 2004.**

**The bid is scheduled to be opened after 9:30 a.m. on March 16, 2004 in the County Commission Chambers, Boone County Government Center, 801 E. Walnut, Columbia, MO 65201.**

Not less than the prevailing hourly rate of wages, as found by the Department of Labor and Industrial Relations of Missouri, shall be paid to all workers performing work under this Contract.

The Contractor's bond shall include such provisions as will guarantee the faithful performance of the prevailing hourly wage rate as provided by the Contract.

Boone County notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.
