Boone County, Missouri is accepting sealed bids for **73-07OCT04 Good Time Acres Neighborhood Improvement Project**

Project Construction: *Construction of approximately 960 linear feet of 24-foot wide Portland cement concrete pavement with concrete curb and gutter on Hoe Down Drive and Square Circle in Good Time Acres Subdivision. The project will include four Type M storm water inlets with associated piping. The project will also include relocation of waterline foe CWD#1*

Sealed bids, subject to the Instructions and General Conditions of Bidding, will be accepted until 1:15 P.M. on October 7, 2004, at the Boone County Purchasing Office, 601 E. Walnut, Room 209, Columbia, Missouri, 65201. Bids received after the above specified time for acceptance will be returned to the sender unopened.

The bid is scheduled to be publicly opened after 1:30 P.M. on October 7, 2004 in the Boone County Commission Chambers, Boone County Government Center, 801 E. Walnut, Columbia, MO 65201.

Not less than the prevailing hourly rate of wages, as found by the Department of Labor and Industrial Relations of Missouri, shall be paid to all workers performing work under this Contract. The Contractor's bond shall include such provisions as will guarantee the faithful performance of the prevailing hourly wage rate as provided by the Contract.
