Boone County, Missouri is accepting sealed bids for **74-12OCT04 Summers Lane Neighborhood Improvement Project**

Project Construction: *The work shall consist of minor road grading preparation, adding rollstone base and paving with asphaltic concrete pavement. Top soil shall be trucked in and used to bring ditch in slope up to new asphalt road grade, fertilized, seeded, and mulched.*

Sealed bids, subject to the Instructions and General Conditions of Bidding, will be accepted until 9:15 A.M. on October 12, 2004, at the Boone County Purchasing Office, 601 E. Walnut, Room 209, Columbia, Missouri, 65201. Bids received after the above specified time for acceptance will be returned to the sender unopened.

The bid is scheduled to be publicly opened after 9:30 A.M. on October 12, 2004 in the Boone County Commission Chambers, Boone County Government Center, 801 E. Walnut, Columbia, MO 65201.

The County reserves the right to select and award the bid item or items which best suit its needs, whether the price is the lowest or not, and also reserves the right to reject any and all bids or waive informalities or irregularities.

Not less than the prevailing hourly rate of wages, as found by the Department of Labor and Industrial Relations of Missouri, shall be paid to all workers performing work under this Contract. The Contractor's bond shall include such provisions as will guarantee the faithful performance of the prevailing hourly wage rate as provided by the Contract.

Boone County notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.
