BID DOCUMENTS:

SECTION 2.1.1. HAS BEEN REVISED AS FOLLOWS:

Scope of Services – The Contractor shall provide all labor, materials, equipment, and supervision to complete the following improvements. Drawings and details are included as Exhibit C.

Base Bid: Clean and repaint primary steel, Repair insulation and install liner panel as shown on drawings.

Bid Alternate #1: Clean and repaint roof purlins.

Bid Alternate #2: Clean and repaint wall girts.

Bid Alternate #3: Clean and repaint structural steel truck bed racks adjacent to Dry Storage Building.

SECTION 2.2.1.1. HAS BEEN REVISED AS FOLLOWS:

All columns and beams in building

See attached drawings for general reference to size of structure and extent of work. Bidder shall visit site prior to bidding to confirm existing conditions for the project (Pre-Bid Meeting scheduled for all interested parties to review site). Work shall include all main frames including columns and roof beams but not including purlins. It shall also include the channels and ladder in the loading area adjacent to the drive through, and other miscellaneous structural steel.

SECTION 2.2.1.2. HAS BEEN REVISED AS FOLLOWS:

Bid Alternate Number 1 includes all surface preparation, primer, and painting of roof purlins.

SECTION 2.2.1.3. HAS BEEN ADDED AS FOLLOWS:

Bid Alternate Number 2 includes all surface preparation, primer, and painting of wall girts.

SECTION 2.2.1.4. HAS BEEN ADDED AS FOLLOWS:

Bid Alternate Number 3 includes surface preparation, prime, and painting all of the columns and beams for the support structures for the truck bed equipment that are adjacent to the main building (north, east, and west).
