Project Construction: This project consists of the complete removal and replacement of Teton Drive and portions of Zion Street with new concrete pavement. The pavement replacement will consist of 1,233 linear feet of 32 foot wide pavement. All driveway approaches adjacent to replaced concrete pavement will be replaced to the right-of-way line. New storm sewer pipes and inlets will be constructed on Zion Street. Concrete pavement panels will be removed and replaced throughout the subdivision as directed by the County Engineer.
