Boone County, Missouri is accepting sealed bids for 83-15DEC05 Trails West Subdivision Storm Water Improvements Project.

**Project Construction**: The project consists of upgrading storm water facilities within the Trails West Subdivision. Three new type M inlets and two new modified type M inlets will be constructed with curb improvements around the proposed inlets. On South Trails Drive a large CMP will be replaced with new arched pipes. They will consist of a 19' section of 66" x 51" arched CMP, a 28' section of 81" x 59" arched CMP, and a 10' section of 95" x 67" arch CMP at the existing stream crossing. There will also be approx. 360 LF of 24" CMP that will be used to connect proposed inlets. This project is located approximately 4 miles west of Columbia and around ½ mile south of the State Highway 40 and Trails West Avenue intersection in western Boone County.

Sealed bids, subject to the Instructions and General Conditions of Bidding, will be accepted until 1:15 P.M. on December 15, 2005, at the Boone County Purchasing Office, 601 E. Walnut, Room 209, Columbia, Missouri, 65201. Bids received after the above specified time for acceptance will be returned to the sender unopened.

The bid is scheduled to be publicly opened after 1:30 P.M. on December 15, 2005 in the Boone County Commission Chambers, 801 E. Walnut, Columbia, MO 65201.

Not less than the prevailing hourly rate of wages, as found by the Department of Labor and Industrial Relations of Missouri, shall be paid to all workers performing work under this Contract. The Contractor's bond shall include such provisions as will guarantee the faithful performance of the prevailing hourly wage rate as provided by the Contract.
