NOTICE TO BIDDERS

Boone County, Missouri is accepting sealed bids for 25-11APR06 State Route K Improvements at Scott Boulevard/CWSD #1 Water Line Relocation Project.

Project Construction: *This project consists of two parts: 1. Relocation of Consolidated Water Supply District #1 (CWSD #1) Water Lines and 2. Reconstruction of approximately 1,825 linear feet of State Route K to improve site distance and construct an intersection, which includes center left turn lanes, for the future connection of Scott Blvd at R.A. Nursery Road. Both parts will be awarded to one contractor under one construction contract. There are times when the water line relocation work and roadway reconstruction will have to be performed concurrently.*

The water line work consists of approximately 1,990 lf of 8" CL200 PVC water line; 150 lf of 8" CL200 restrained joint PVC water line; 13 ea gate valves (4"-8"); 5 ea ties to existing lines (4"-8"); 60 lf of 14" steel encased bore with 8" CL200 Restrained Joint PVC pipe; 135 lf of 14" steel encased open cut with 8" CL200 PVC pipe (3 locations); 1,500 lbs. of ductile iron fittings; relocation of 1 existing fire hydrant; and other appurtenances including locator wire, anchor couplings, service lines, caps, thrust blocks, flushing/ cleaning, sterilization, testing, and surface restoration.

The roadway work consists of approximately 25,490 cy of earth excavation (raw cut), 18,770 cy of compacted embankment (raw fill); 11.5 stations of compacting in cut; 800 lf of interception levee berm; 1.5 acres of clearing and grubbing; removals; 225 lf of Type A Guard Rail; 2 ea Type A crashworthy end terminals; 256 CY of Type 2 rock ditch liner; 28 cy of rock lining at culvert outlets; traffic control; pavement marking; 43 lf of 15" group B culvert; 56 lf of 24" Class III RCP; 171 lf of Class III RCP; 1 ea MoDOT 5'x3' Type S-1 drop inlet; 2 ea 24" RCP flared end section; 2 ea 42" RCP flared end section; 2ea beveled pipe end treatment; 4.2 acres surface restoration; erosion control; 360 lf of traffic signal conduit; PVC settling tank drain and roof drain relocation; 118 sy of 8" thick aggregate pavement transition; 9,464 SY of 8" thick pavement on 4" Type I aggregate base (Alternate bid options for 8" thick asphalt or 8" thick concrete pavement will be accepted; and 226 SY of 6" thick pavement on 4" Type I aggregate base (Alternate bid options for 6" thick asphalt or 6" thick concrete pavement will be accepted.

Sealed bids, subject to the Instructions and General Conditions of Bidding, will be accepted until 9:15 A.M. on April 11, 2006, at the Boone County Purchasing Office, 601 E. Walnut, Room 209, Columbia, Missouri, 65201. Bids received after the above specified time for acceptance will be returned to the sender unopened.

The bid is scheduled to be publicly opened after 9:30 A.M. on April 11, 2006 in the Boone County Commission Chambers, 801 E. Walnut, Columbia, MO 65201.

The County reserves the right to select and award the bid item or items which best suit its needs, whether the price is the lowest or not, and also reserves the right to reject any and all bids or waive informalities or irregularities.

Not less than the prevailing hourly rate of wages, as found by the Department of Labor and Industrial Relations of Missouri, shall be paid to all workers performing work under this Contract. The Contractor's bond shall include such provisions as will guarantee the faithful performance of the prevailing hourly wage rate as provided by the Contract.

Boone County notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award. The bidder will insure that Disadvantage Business Enterprises will have the opportunity to participate in the performance of this contract or any subcontracts.

Bids must be on forms provided and all unit price bids, extensions, and totals provided thereon shall be completed fully.
