NOTICE TO BIDDERS

Boone County, Missouri is accepting sealed bids for 31-04MAY06 Martin Lane & Crump Lane Paving Improvements.

Project Construction: *Full depth paving of 4" bituminous base (4,003 tons), and 2" surface asphalt (1,962 tons) over existing aggregate base (completed surface to have 20' width). Placement of asphalt will start at the intersection of Crump Lane and Clellie Harmon Rd and proceed to the intersection of Martin Lane and Old Highway 63. Mill joints, transitions, and aprons will be required.*

Sealed bids, subject to the Instructions and General Conditions of Bidding, will be accepted until 1:15 P.M. on May 4, 2006, at the Boone County Purchasing Office, 601 E. Walnut, Room 209, Columbia, Missouri, 65201. Bids received after the above specified time for acceptance will be returned to the sender unopened.

The bid is scheduled to be publicly opened after 1:30 P.M. on May 4, 2006 in the Boone County Commission Chambers, 801 E. Walnut, Columbia, MO 65201.

The County reserves the right to select and award the bid item or items which best suit its needs, whether the price is the lowest or not, and also reserves the right to reject any and all bids or waive informalities or irregularities.

Not less than the prevailing hourly rate of wages, as found by the Department of Labor and Industrial Relations of Missouri, shall be paid to all workers performing work under this Contract. The Contractor's bond shall include such provisions as will guarantee the faithful performance of the prevailing hourly wage rate as provided by the Contract.

Boone County notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.
