**Boone County, Missouri is accepting sealed bids for 32-04MAY06 Asphalt Overlay & Roadway Drainage Improvements.**

**Project Construction:** *To remove and replace select driveway and roadway culverts, re-work existing ditches and create positive drainage where required, adding storm water improvements with erosion control measures and restoration, dig out repair and milling on asphalt roadways / shoulders, a small amount of concrete milling and replacement, placement of asphalt wedging and overlaying of Bethel Church Road, Wagon Trail Road, Creasy Springs Road, N. Mt. Pleasant Road, Mt. Hope Road, Old Highway 63 South, Clays Fork Road, Gillespie Bridge Road and Scott Blvd.*

The Contractor's bond shall include such provisions as will guarantee the faithful performance of the prevailing hourly wage rate as provided by the Contract.
