Boone County, Missouri is accepting sealed bids for 79-02NOV06 Georgetown Subdivision Drainage Improvements.

Scope of Project Construction: *This project consists of the complete removal and replacement of 15 storm sewer inlets at locations on Georgetown Loop, Lexington Circle, Lexington Court, Waterford Drive, Millbrook Court, and Georgetown Drive as shown on the plans. Concrete pavement panels will be removed and replaced at locations requiring pipe replacement under the street as directed by the County Engineer. Rip-rap will be placed at pipe outfalls. See Special Provisions.*

Sealed bids, subject to the Instructions and General Conditions of Bidding, will be accepted until 1:15 P.M. on Thursday, November 2, 2006, at the Boone County Purchasing Office, 601 E. Walnut, Room 209, Columbia, Missouri, 65201. Bids received after the above specified time for acceptance will be returned to the sender unopened.

The bid is scheduled to be publicly opened after 1:30 P.M. on Thursday, November 2, 2006 in the Boone County Commission Chambers, 801 E. Walnut, Columbia, MO 65201.

The County reserves the right to select and award the bid item or items which best suit its needs, whether the price is the lowest or not, and also reserves the right to reject any and all bids or waive informalities or irregularities.

Not less than the prevailing hourly rate of wages, as found by the Department of Labor and Industrial Relations of Missouri, shall be paid to all workers performing work under this Contract. The Contractor's bond shall include such provisions as will guarantee the faithful performance of the prevailing hourly wage rate as provided by the Contract.

Boone County notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.
