NOTICE TO BIDDERS

Boone County, Missouri is accepting sealed bids for 83-16NOV06 Jemerson Creek Road Bank Stabilization.

Scope of Project Construction: *The project consist of the reinforcement of about 300 linear feet of the left bank of Jemerson Creek, consisting of one stretch measuring about 210 linear feet and one stretch measuring about 90 linear feet. All vegetation, except live trees with a trunk diameter larger than 4 inches, will be removed. The bank will be regraded to provide a continuous surface. The reinforcement will be made with approximately 930 cubic yards of MoDOT Type 2 Rock Blanket placed on top of approximately 815 square yards of geotextile fabric. The project is located adjacent to South Jemerson Creek Road, about ¼ mile from it's intersection with Hart Creek Road, at a distance of approximately 8 miles from Ashland, Missouri.*

Sealed bids, subject to the Instructions and General Conditions of Bidding, will be accepted until 1:15 P.M. on Thursday, November 16, 2006, at the Boone County Purchasing Office, 601 E. Walnut, Room 209, Columbia, Missouri, 65201. Bids received after the above specified time for acceptance will be returned to the sender unopened.

The bid is scheduled to be publicly opened after 1:30 P.M. on Thursday, November 16, 2006 in the Boone County Commission Chambers, 801 E. Walnut, Columbia, MO 65201.

The County reserves the right to select and award the bid item or items which best suit its needs, whether the price is the lowest or not, and also reserves the right to reject any and all bids or waive informalities or irregularities.

Not less than the prevailing hourly rate of wages, as found by the Department of Labor and Industrial Relations of Missouri, shall be paid to all workers performing work under this Contract. The Contractor's bond shall include such provisions as will guarantee the faithful performance of the prevailing hourly wage rate as provided by the Contract.

Boone County notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award. The bidder will insure that Disadvantage Business Enterprises will have the opportunity to participate in the performance of this contract or any subcontracts.
