AND BROWN SCHOOL ROAD)



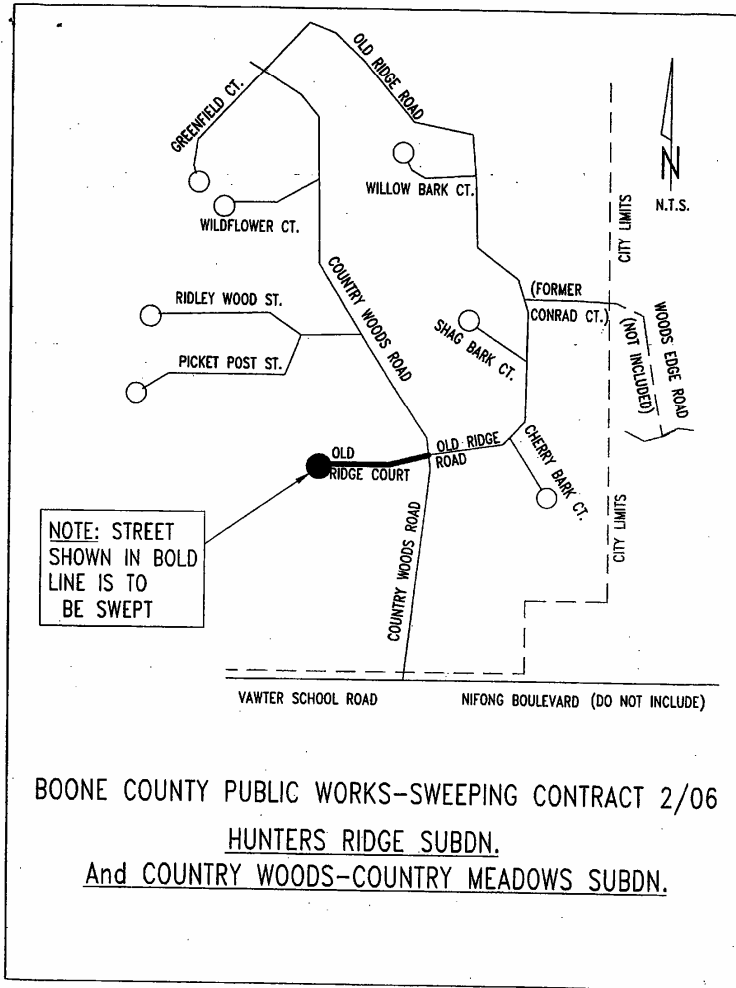

(EXCLUDING STATE ROUTE K)

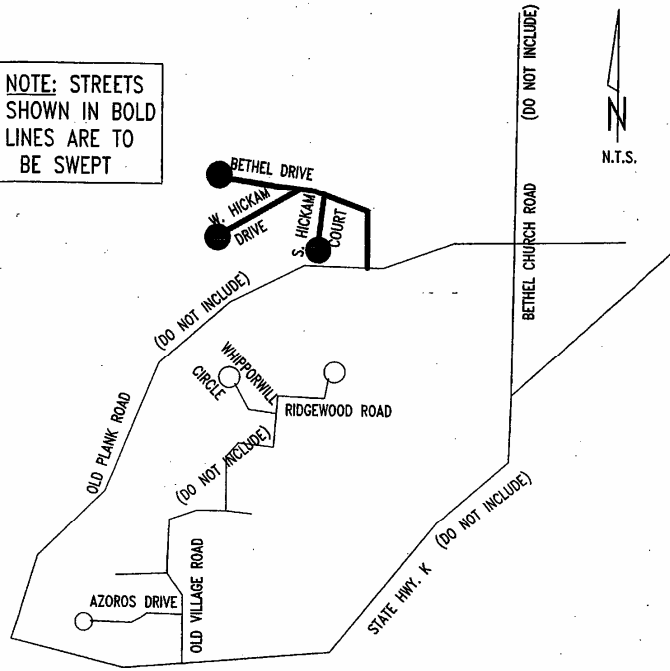

And, EXCLUDING BETHEL CHURCH ROAD)



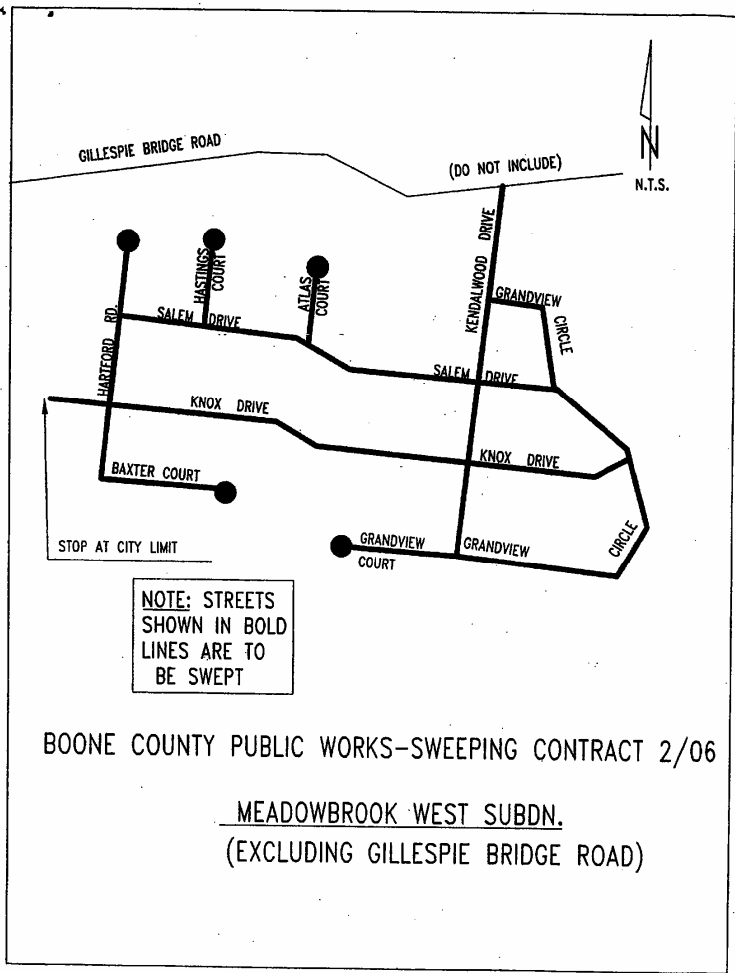

(EXCLUDING STATE ROUTE 763)



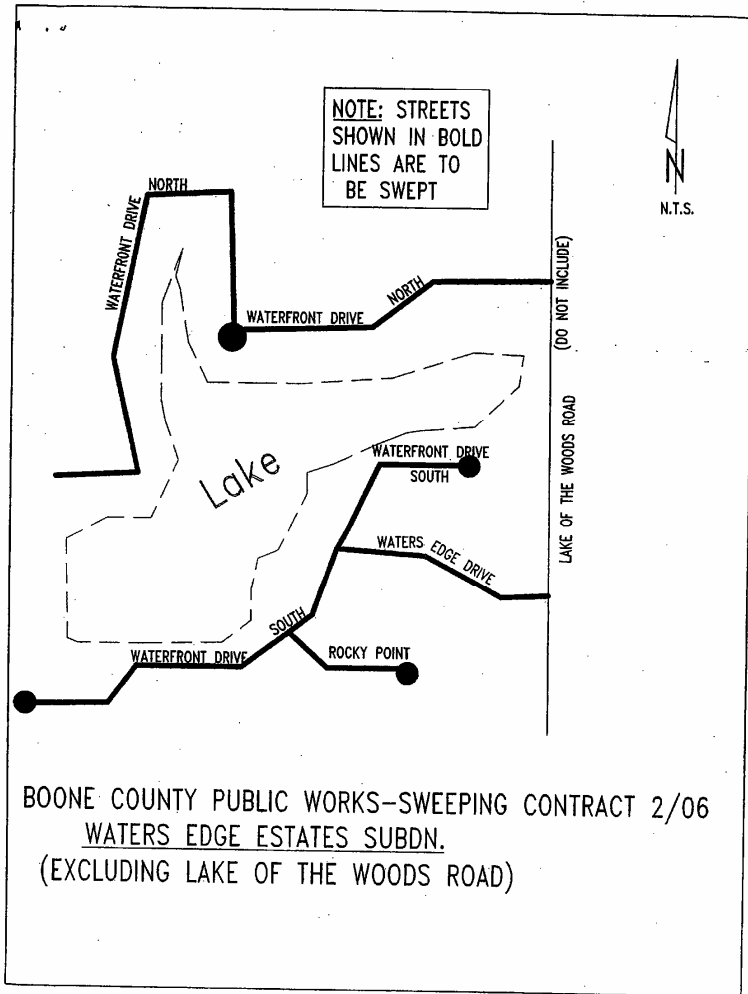


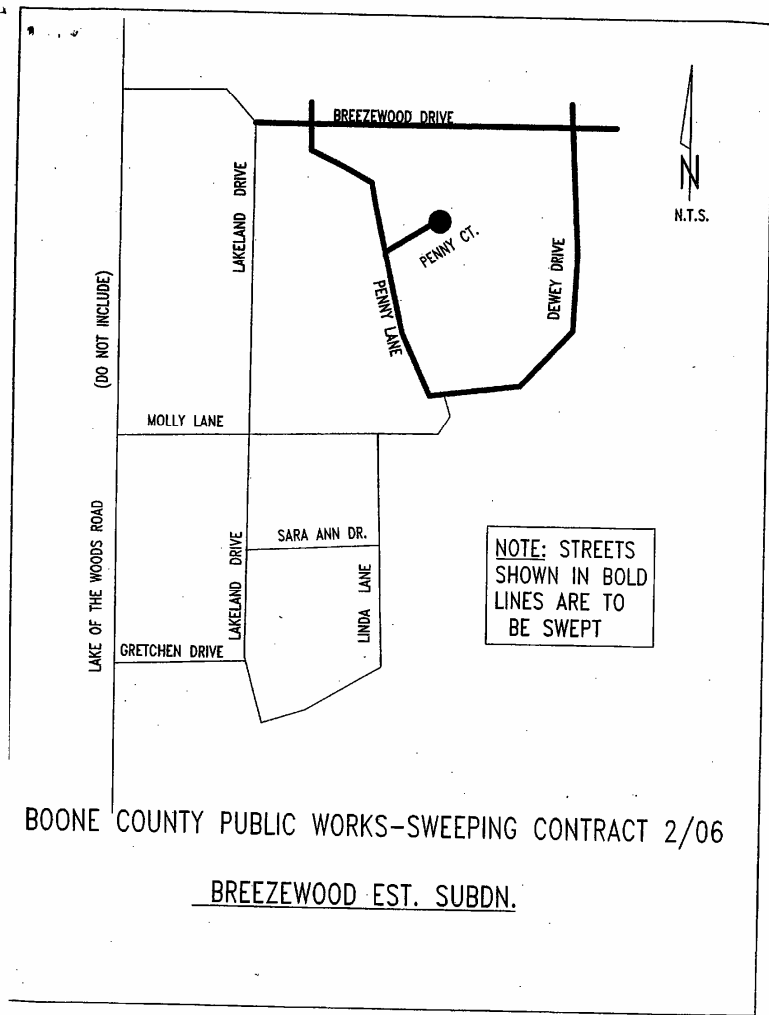




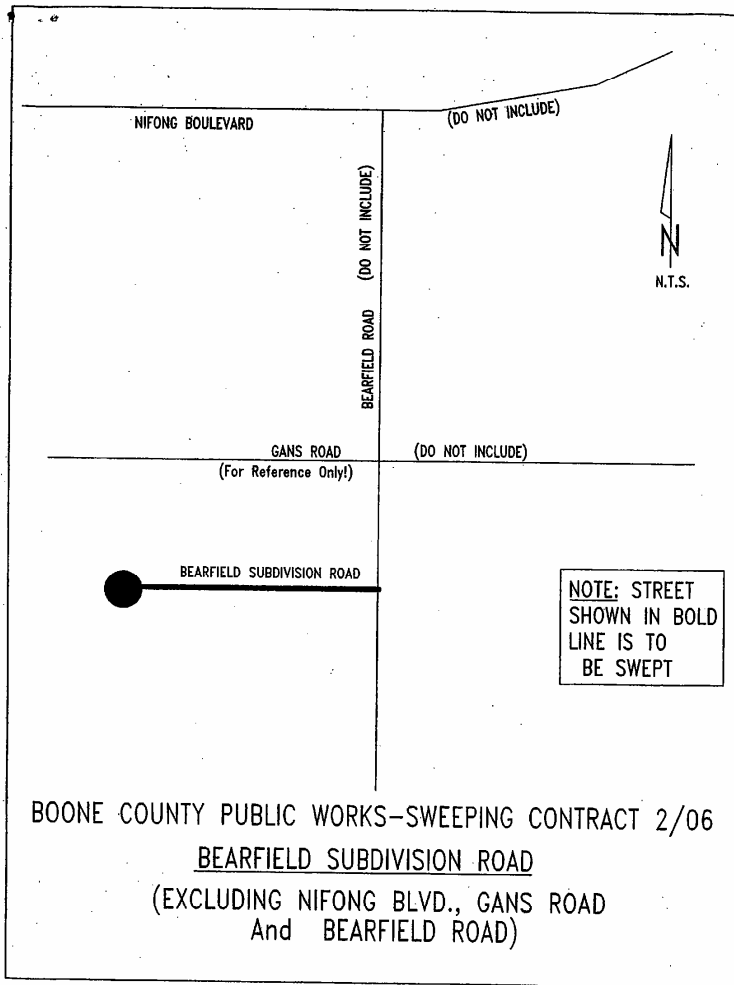
