- 1. Section 01010, Part 1, 1.3, F. "The Contractor shall restrict hours of operation from 7:00 am to 8:00 pm on Monday through Friday, except in the case of an emergency." Shall not apply to this project.
- 2. Special Provision 2. "No one bridge shall be closed to through traffic for part of or the entirety of any 10 consecutive days throughout the course of work." shall not apply to this project.
- 3. The hydro-demolition removal equipment shall be calibrated for a target depth of 0.5".
- 4. The use of Class B-2 Concrete for partial and full depth repairs will not be required on this project. An integral pour of Latex Modified Concrete will be allowed for partial/full depth repair and surface course.
- 5. Section 108.7.2.1 of the Missouri Standard Specifications for Highway Construction which states, "December 15 to March 15, both dates inclusive and Saturdays, Sundays, and holidays established by law will not be counted as working days." shall not apply to this project.


