ADDENDUM #1 - Issued October 26, 2009

This addendum is issued in accordance with the Introduction and General Terms and Conditions of Bidding in the Request for Bid and is hereby incorporated into and made a part of the Request for Bid Documents. Offerors are reminded that receipt of this addendum **MUST** be acknowledged and submitted with Offeror's *Response Form*.


Specifications for the above noted Request for Bid and the work covered thereby are herein modified as follows, and except as set forth herein, otherwise remain unchanged and in full force and effect:

- I. **Clarification:** Bid number *65-04NOV09 – Furnishing and Installation of Walk-In Cooler* - bid is not for the actual walk-in cooler, but for the repair of the existing walk-in cooler.
- II. Delete paragraphs 2.6., 2.7., 2.8.1. and add the following:
 - a. For the furnishing, delivery and installation of new refrigeration unit and evaporator on walk-in cooler. Furnish, deliver and install the above with new TXV, solenoid, thermostat and P-trap. Installation shall include running new lines, labor, unit, evaporator and materials. The evacuation of the unit and the recharge must be included along with disposal of old materials. Vendor bid must include all labor and materials required for the above project.
- III. Change in paragraph 2.9.1. "Public Works Director" to "Facilities Maintenance Manager".
- IV. Delete from paragraph 2.12.3. – "This job is expected to have work hours that are outside of the normal business hours. Work will be performed on nights and weekends as instructed".
- V. Change in paragraph 2.16.4. "Replacement of the Walk-in Cooler" to "Repair of the Walk-In Cooler".
- VI. Delete from paragraph 2.17 "Site Visits may be scheduled by contacting Tyson Boldan". And replace with: "A site visit is **mandatory** in order to bid on this repair. A site visit **MUST** be scheduled by calling Tyson Boldan at (573) 886-4392. The sign-in sheet at the Sheriff Department must be signed following the site visit".
- VII. Delete the Prevailing Wage References in this bid (Paragraphs 2.20.1. through 2.20.9 and the attached Prevailing Wage Notice). This work is considered maintenance and Prevailing Wage does not apply.
