Walnut, Columbia, MO 65201, The bid openig will take place after 1:30 P.M. in the same office.
- III. Replace section II of Addendum #1 with the following:

By:

A. For the furnishing, delivery and installation of new refrigeration unit and evaporators on walk-in cooler. Furnish, deliver and install the above with new TXV, solenoid, thermostat and P-trap. Installation shall include running new lines, labor, unit, both evaporators and materials. The evacuation of the unit and the recharge must be included along with disposal of old materials. Vendor bid must include all labor and materials required for the above project.
