Specifications for the above noted Request for Bid and the work covered thereby are herein modified as follows, and except as set forth herein, otherwise remain unchanged and in full force and effect:

1) Replace the June 15, 2012 completion date in the RFP with the following:

Lead time on equipment is believed to be 4-6 weeks, possibly as long as 10 weeks. Please complete calendar days to complete work following receipt of Notice to Proceed: ______ days

- 2) Relocate 1 1/4" sprinkler line as required at AHU1 to miss new Economizer ductwork.
- 3) The County received the following questions and is providing responses below:
 - a) Question: Is the work to be completed during the week or on weekends? Response: Air handlers need to be operational from 8:00 a.m. 5:00 p.m. Monday through Friday. All work that will require the air handlers to be turned off shall be done in off hours (before 8:00 a.m. and after 5:00 p.m. during the week and week-ends). Other work that does not require air handlers to be turned off may be completed during regular, week day work hours.
 - **b)** Question: Will planters need to be relocated?

Response: All planters on Judge's Patio are able to stay where located at this time.
