GENERAL REQUIREMENTS FOR COUNTY STORMWATER DISCHARGE AND LAND DISTURBANCE PERMITS THAT CONSULTANTS/OWNERS/DEVELOPERS SHOULD KNOW ABOUT

COUNTY STORMWATER DISCHARGE PERMIT GENERAL REQUIREMENTS*:

- Request a Pre-Application Meeting with Resource Management
 - Submit a Pre-Application Plan in accordance with Section 2.5 of the Boone County Stormwater Manual and the attached Pre-Application Plan Requirements checklist a minimum of 1 week prior to the desired meeting date (meetings are held on the 2nd and 3rd Mondays of each month)
 - Owner/Developer and their engineer should attend
- Preliminary Stormwater Management Plan approval
 - \$50 Stormwater Discharge Permit application fee (Check payable to Boone County)
 - Preliminary Stormwater Management Plan
 - Mandatory Stormwater Forms and calculations
 - Limited Stream Assessment (If applicable)
- Stormwater Management Construction Plan approval
 - Stormwater Management Construction Plan
 - Mandatory County Stormwater Forms and calculations
 - Limited Stream Assessment (If applicable)
- Copies of permits or approvals from other agencies (If applicable) (USACOE, MODNR, etc.)
- Easements (If applicable)
 - Recording fee for easements (If applicable)
- Stormwater Management/BMP Facilities Maintenance Agreement
 - Recording fee for Stormwater Management/BMP Facilities Maintenance Agreement

COUNTY LAND DISTURBANCE PERMIT GENERAL REQUIREMENTS*:

- Boone County Land Disturbance Permit Application form including:
 - \$150 Boone County Land Disturbance Permit application fee (Check payable to Boone County)
 - Copy of approved Stormwater Management Construction Plan (If applicable)
 - Limited Stream Assessment (If applicable)
 - Stormwater Pollution Prevention Plan (SWPPP)
 - Erosion and Sediment Control Plan
 - Itemized List of Erosion and Sediment Control BMP Quantities
 - Copies of MODNR Land Disturbance Permit forms
- Copy of MODNR Land Disturbance Permit approval
- Copies of permits or approvals from other agencies (If applicable) (USACOE, etc.)
- Cash bond, cash or equivalent, certificate of deposit, surety bond or letter of credit of not less than 150% of the value of all erosion and sediment control measures which are part of the SWPPP (Amount will be calculated by Boone County)

* These general requirements are provided for convenience. Detailed requirements can be found in the Boone County Stormwater Ordinance and Boone County Stormwater Manual. Environmentally sensitive areas have additional requirements that are not listed here.
